INTERVENTION

- 1 - The Attorney General is intervening in the motion "*de bene esse* for authorization to suspend certain payments to Pensions Plans maintained by the Petitioners";
- 2 - In this motion, it is alleged that all of the pension plans of the debtor are registered with the Canada Revenue Agency and with the relevant provincial authorities;
- 3 - It appears that the pension plan of the debtor Bowater Forest Products of Canada Inc. is in fact registered with the Office of the Superintendent of Financial Institutions and is therefore subject to the federal *Pension Benefits Standards Act* (R.S.C. 1985, c. 32 (2nd supp.);
- 4 - As of the date of the initial order, no "special payments" were due by that debtor;

- 5 - The motion of the applicants is therefore not applicable with respect to the debtor Bowater Forest Products of Canada Inc. and therefore this company should be excluded from the co-applicants or at a minimum, the judgment to be rendered on this motion should mention that this particular debtor is not affected by that judgment;
- 6 - This intervention by the Attorney General applies only to the motion "*de bene esse* for authorization to suspend certain payments to Pensions Plans maintained by the Petitioners". The intervener reserves its right to file a motion to modify the initial order.
