MOTION FOR AN ORDER EXTENDING THE STAY PERIOD
(Sections 9 and 11 of the *Companies' Creditors Arrangement Act*, R.C.S. 1985 c. C-36)

TO THE HONOURABLE CLÉMENT GASCON J.S.C. OR TO ONE OF THE
HONOURABLE JUDGES OF THE SUPERIOR COURT, SITTING IN
COMMERCIAL DIVISION, IN AND FOR THE JUDICIAL DISTRICT OF
MONTRÉAL, THE PETITIONERS RESPECTFULLY SUBMIT THE FOLLOWING:

A. PREAMBLE

1. On April 17, 2009, this Honourable Court issued an order (as subsequently amended and restated, the "**Initial Order**") pursuant to the *Companies' Creditors Arrangement Act* (the "**CCAA**") in respect of (i) Abitibi-Consolidated Inc. ("**ACI**") and subsidiaries thereof (collectively, the "**Abitibi Petitioners**")¹ (ii) Bowater Canadian Holdings Inc. and subsidiaries and affiliates thereof (collectively, the "**Bowater Petitioners**")² and (iii) certain partnerships.³ Any undefined capitalized expressions used herein have the meanings set forth in the Initial Order.
2. On April 16, 2009, AbitibiBowater Inc. ("**ABH**"), Bowater Inc. and certain of their U.S. and Canadian subsidiaries filed voluntary petitions for relief under Chapter 11 of the *U.S. Bankruptcy Code* (the "**Chapter 11 Proceedings**") in the United States Bankruptcy Court for the District of Delaware (the "**U.S. Court**") and on April 17, 2009, ABH and certain Petitioners (collectively with ABH, the "**18.6 Petitioners**")⁴ obtained orders under s. 18.6 of the CCAA in respect of the Chapter 11 Proceedings (the 18.6 Petitioners, the Abitibi Petitioners and the Bowater Petitioners being collectively referred to as the "**Petitioners**").
3. Pursuant to the Initial Order, Ernst & Young Inc. was appointed as monitor of the Petitioners (the "**Monitor**") and a stay of proceedings (the "**Stay of Proceedings**") was issued from the date of the Initial Order until May 14, 2009 (the "**Stay Period**").
4. The Stay Period was extended on six occasions by orders of this Court dated respectively May 14, September 4, December 11, 2009, March 12, June 9, 2010 and July 9, 2010 (the latter being the "**Sixth Stay Extension Order**"), the whole as appears from the Court record. The Stay Period, as extended by the Sixth Stay Extension Order, expires on September 8, 2010.

B. ORDER SOUGHT

5. The Petitioners hereby seek the issuance of an order extending the Stay Period until September 30, 2010.

C. RECENT DEVELOPMENTS

6. Since the issuance of the Sixth Stay Extension Order, the Petitioners have made and continue to make significant efforts to address the concerns of all stakeholders.
7. Several recent developments concerning the Petitioners' restructuring efforts under the CCAA were already detailed in the Petitioners' Motion which led to the Fifth Stay Extension Order, the whole as appears from the Court record.
8. On July 9, 2010, this Court issued an order (the "**Creditors' Meeting Order**") authorizing the Petitioners to, *inter alia*, convene, hold and conduct separate meetings of their creditors (the "**Creditors' Meeting**") on August 26, 2010, in Montréal, Québec, to consider and, if thought advisable, approve the restructuring plan proposed to the Petitioners' creditors in the present proceedings (the "**CCAA Plan**"), the whole as appears from the Court record.
9. The Creditors' Meeting Order also provided for an hearing (the "**Sanction Hearing**") on September 8, 2009 to allow the Court to consider and, if determined to be appropriate, grant an order sanctioning the CCAA Plan.
10. On July 21, 2010 this Court issued an amendment to the Creditors' Meeting Order, thereby amending the date of the Creditors' Meeting to September 14, 2010 and that of the Sanction Hearing to September 20, 2010, the whole as appears from the Court record.

D. GROUND FOR THIS MOTION

11. The Petitioners are requesting an extension of the Stay Period until September 30, 2010. The requested extension of the Stay Period is necessary in light of the amendments to the dates of the Creditors' Meeting and Sanction Hearing.
12. Since the issuance of the Sixth Extension Order, the Petitioners have acted, and continue to act, in good faith and with due diligence. As such, the Petitioners continue to work on implementing and maintaining effective procedures to permit an efficient monitoring of their financial situation, along with the assistance of the Monitor, when required.
13. The Monitor has indicated that it will be filing the Fifty-Fourth Report of the Monitor (the "**Monitor's 54th Report**") which shall contain its recommendations and a review of the cash flow forecast of the Petitioners through and including October 31, 2010.

14. As appears from the cash flow forecast, the Petitioners are of the view that no creditor will suffer any undue prejudice by the extension of the Stay Period as the Petitioners forecast to have sufficient liquidity during that period.
15. The Petitioners are of the view that extending the Stay Period to September 30, 2010 based upon the cash flow forecast to be reported upon in the Monitor's 54th Report is appropriate in the present circumstances.
16. Based on the foregoing, the Petitioners request that this Court further extend the Stay Period up to and including September 30, 2010, which date shall be the new Stay Termination Date, the whole subject to all the other terms of the Initial Order, as amended.
17. The Petitioners respectfully submit that the notices given of the presentation of the present Motion are proper and sufficient.
18. The present Motion is well founded in fact and in law.

WHEREFORE, MAY IT PLEASE THIS HONOURABLE COURT TO:

GRANT the present Motion;

EXTEND the Stay Period (as defined in the Initial Order granted by this Court in this matter, as amended) until September 30, 2010 the whole subject to all the other terms of the Initial Order, as amended;

DECLARE that the notices given of the presentation of the present Motion are proper and sufficient;

ORDER the provisional execution of this Order notwithstanding any appeal and without the necessity of furnishing any security.

THE WHOLE WITHOUT COSTS, save and except in case of contestation.

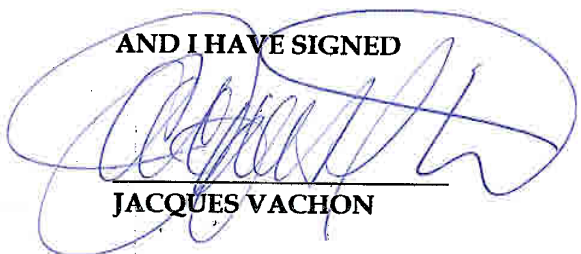

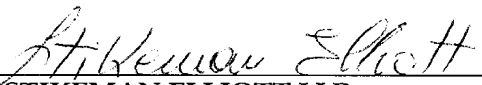
