AFFIDAVIT OF ULRICH FELBERMAYR

I, Ulrich Felbermayr, of the City of Saskatoon, in the Province of Saskatchewan, MAKE
OATH AND SAY AS FOLLOWS:

1. I am a senior investment manager for Golden Opportunities Fund Inc. ("GOF"), one of the subordinated secured debtors of Big Sky Farms Inc. ("Big Sky") and as such I have a personal knowledge of the facts deposed to herein except where stated to be on information and belief, in which case I verily believe same to be true.
2. There are five subordinated secured debtors of Big Sky, namely:
 - (i) Golden Opportunities Fund Inc. ("GOF");

- (ii) CIC Asset Management Inc. (formerly Investment Saskatchewan Inc.) (“CIC”);
 - (iii) FCC Ventures, a division of Farm Credit Canada (“FCCV”);
 - (iv) Florion Possberg (“Possberg”); and
 - (v) Cliff Weigers (“Weigers”)
3. I have reviewed the Affidavit of Canute Tagseth sworn October 29, 2009 in this matter and state that the interest calculations set out in paragraphs 70, 73 and 76 of Mr. Tagseth's affidavit are in error. Specifically:
- i. as it relates to paragraph 70, the interest owed to GOF as at October 17, 2009 is \$415,477.78 and not \$235,788.00;
 - ii. as it relates to paragraph 70, I am advised by John Kennedy, Vice President of Avrio Investments Inc., who is the portfolio manager and attorney for FCCV (“Kennedy”) that the interest owed to FCCV as at October 17, 2009 is \$399,426.68 and not \$219,863.00;
 - iii. as it relates to paragraph 73, the interest owed to GOF as at October 17, 2009 is \$71,693.14 and not \$72,955.46;
 - iv. as it relates to paragraph 73, I am advised by Kennedy that the interest owed to FCCV as at October 17, 2009 is \$71,693.14 and not \$72,955.46;
 - v. as it relates to paragraph 76, the interest owed to GOF as at October 17, 2009 is \$42,822.98 and not \$42,710.75; and

- vi. as it relates to paragraph 76, I am advised by Kennedy that the interest owed to FCCV as at October 17, 2009 is \$42,822.98 and not \$42,710.75.
