**NOTICE OF MOTION**  
**(Seeking Aid of U.S. Bankruptcy Court)**

**TAKE NOTICE** that an application will be made to the Honourable Mr. Justice N.G. Gabrielson in Chambers at the Court House, 520 Spadina Crescent East, Saskatoon, Saskatchewan, on Friday, the 18th day of December, 2009, at nine (9:00) o'clock in the forenoon, or so soon thereafter as counsel may be heard on behalf of the Applicants, Big Sky Farms Inc., Drycast Systems Inc. and Big Sky Management Consulting Corp. (collectively, the "**Applicants**" or "**Big Sky**") for the following items of relief, pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36 (the "CCAA"), the *Ex Parte* Initial Order of the Honourable Mr. Justice N.G. Gabrielson dated and issued in these proceedings on November 10, 2009, as amended by subsequent Orders of the Honourable Mr. Justice N.G. Gabrielson (the "**Initial Order**") and the inherent jurisdiction of this Honourable Court, namely:

- A. An Order declaring that the time for service of this Notice of Motion and the materials filed by the Applicants in support of this Notice of Motion is hereby abridged, such that this application is properly returnable on December 18, 2009 and further service thereof on any other person is hereby dispensed with.
- B. An Order requesting the aid and assistance of the United States Bankruptcy Court for the

Northern District of Iowa in hearing and determining the following matters (collectively, the “**Lien Issues**”), namely:

- i. the validity and enforceability of liens claimed by DEL-uxe Feeds, Inc and Farmers Cooperative Company of Hinton (collectively, the “**Claimants**”) under Iowa Code Chapter 570A against the livestock of Big Sky located in Iowa and the proceeds thereof (collectively, the “**Lien Claims**”); and
- ii. the priority of the Lien Claims of the Claimants in relation to the claims of other creditors of Big Sky;

C. An Order requesting that the United States Bankruptcy Court for the Northern District of Iowa give consideration to recognizing and applying the *Guidelines Applicable to Court-to-Court Communications in Cross-Border Cases* (as adopted by The American Law Institute on May 16, 2000 and the International Insolvency Institute on June 10, 2001) in regard to such matters pertaining to the Lien Issues (if any) as the United States Bankruptcy Court for the Northern District of Iowa may determine ought properly to be the subject of court-to-court communications between that Court (on the one hand) and the Court of Queen’s Bench For Saskatchewan (on the other hand).

**AND FURTHER TAKE NOTICE** that the grounds to be argued in support of this application are as follows, namely:

1. On November 12, 2009, the United States Bankruptcy Court for the Northern District of Iowa, on the petition of the Monitor acting as a foreign representative of Big Sky, made an Order Granting Provisional Relief pursuant to 11 U.S.C. 1519.
2. A petition to recognize these CCAA proceedings as a foreign main proceeding pursuant to 11 U.S.C. 1517 is currently before the United States Bankruptcy Court for the Northern District of Iowa for determination.
3. The Applicants are requesting that this Honorable Court set February 3, 2010 as the date for a meeting of Big Sky’s creditors to vote on approving a Plan of Arrangement to be filed by Big Sky (the “**Creditors’ Meeting**”). A determination of the validity,

enforceability and priority of the Lien Claims is necessary in order to clarify the status of the Claimants to participate in the Creditors' Meeting and to consider and vote on the Plan of Arrangement.

4. It is common ground between the Applicants and the Claimants (and it is not anticipated to be the source of significant controversy) that the validity, enforceability and priority of the Lien Claims ought to be determined in accordance with Iowa law.
5. The Claimants are located in Iowa.
6. The United States Bankruptcy Court for the Northern District of Iowa appears to be the proper forum to hear and determine the Lien Issues.
7. The Judges of the Court of Queen's Bench For Saskatchewan have adopted the *Guidelines Applicable to Court-to Court Communications in Cross-Border Cases* (as adopted by The American Law Institute on May 16, 2000 and the International Insolvency Institute on June 10, 2001). Such Guidelines may prove to be of assistance to this Court and to the United States Bankruptcy Court for the Northern District of Iowa in regard to the disposition of the Lien Issues.
8. Such further and other grounds as counsel to the Applicants may identify and this Honourable Court may see fit to consider.

**AND FURTHER TAKE NOTICE** that in support of this application will be read:

2. The First Report of the Monitor;
3. The Second Report of the Monitor;
4. The Claims Process Order;
5. A form of Draft Order;
