OF CANUTE TAGSETH

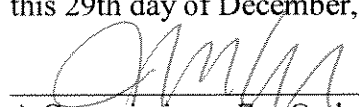
I, **CANUTE TAGSETH**, of the City of Saskatoon, in the Province of
Saskatchewan, Chartered Accountant, **MAKE OATH AND SAY THAT:**

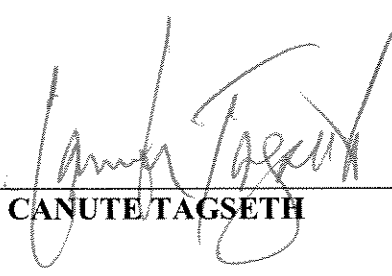
1. I am employed as the Chief Financial Officer of the Applicant, Big Sky Farms Inc., such that I have personal knowledge of the facts and matters hereinafter deposed to, except where stated to be based upon information and belief, and where so stated I do verily believe the same to be true.
2. I make this Fifth Supplementary Affidavit to supplement the Affidavit sworn by me on October 29, 2009; the Supplementary Affidavit sworn by me on November 2, 2009; the Second Supplementary Affidavit sworn by me on December 4, 2009; the Third Supplementary Affidavit sworn by me on December 8, 2009 and the Fourth Supplementary Affidavit sworn by me on December 16, 2009, each of which Affidavits have been filed on behalf of Big Sky Farms Inc., Drycast Systems Inc. and Big Sky Management Consulting Corp. (collectively, the "**Applicants**" or "**Big Sky**") in support of these proceedings.
3. Big Sky has developed a Plan of Arrangement under the *Companies' Creditors Arrangement Act* dated December 29, 2009 (the "Plan"). A copy of the Plan is being filed with the Court on December 29, 2009.

4. Words and phrases contained in this Fifth Supplementary Affidavit which begin with capital letters but which are not expressly defined herein are intended by me to have the meanings which are ascribed to such words and phrases in the Plan.
5. The content of the Plan has been approved by the Senior Secured Lenders and the Sub-Debt Holders.
6. Article 9.2 of the Plan provides that the implementation of the Plan is conditional upon, among other things, the completion of the Restructuring Transactions described in Schedule "B" to the Plan, including the Senior Secured Lenders making available to Big Sky the Exit Loan Facility described in the Plan.
7. Big Sky has been working to negotiate and conclude a binding agreement with the Senior Secured Lenders regarding the terms and conditions upon which the Exit Loan Facility will be advanced to Big Sky by the Senior Secured Lenders. It is the view of Big Sky that the terms and conditions of the Exit Loan Facility will have to be made the subject of a binding agreement between Big Sky and the Senior Secured Lenders on or before January 15, 2010, failing which Big Sky may be required to return to Court to seek further direction of the Court as may be required in the circumstances.
8. Big Sky is continuing discussions and negotiations with the Senior Secured Lenders toward concluding the terms and conditions of the Exit Loan Facility, with a view to concluding that process and achieving a binding agreement on same on or before January 15, 2010. Those discussions are proceeding in a positive and constructive fashion.
9. I make this Fifth Supplementary Affidavit in support of an application by Big Sky for an Order authorizing the filing of the Plan and the conduct of a creditors'

meeting to consider the Plan, all as more particularly described in the Notice of Motion on behalf of Big Sky dated December 29, 2009.
