NOTICE OF MOTION
(Authorizing Filing of Plan of Arrangement & Creditors' Meeting;
Extension of Stay)

TAKE NOTICE that an application will be made to the Honourable Mr. Justice N.G. Gabrielson in Chambers at the Court House, 520 Spadina Crescent East, Saskatoon, Saskatchewan, on Tuesday, the 5th day of January, 2010, at two (2:00) o'clock in the afternoon, or so soon thereafter as counsel may be heard on behalf of Big Sky Farms Inc., Drycast Systems Inc. and Big Sky Management Consulting Corp. (collectively, the "**Applicants**" or "**Big Sky**") for the following items of relief pursuant to sections 6, 12 and 22 of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36 (the "**CCAA**"), the *Ex Parte* Initial Order of the Honourable Mr. Justice N.G. Gabrielson dated and issued in these proceedings on November 10, 2009, as amended by subsequent Orders of the Honourable Mr. Justice N.G. Gabrielson (the "**Initial Order**"); the Order (Extension of Stay; Modification of Administration Charge; Extension of Deadline for Filing a Plan of Arrangement) of the Honourable Mr. Justice N.G. Gabrielson dated and issued in these proceedings on December 9, 2009 (the "**Extension and Modification Order**"); the Order (Claims Process) of the Honourable Mr. Justice N.G. Gabrielson dated and issued in these proceedings on December 9, 2009 (the "**Claims Process Order**"); and the inherent jurisdiction of this Honourable Court, namely:

- A. An Order declaring that the time for service of this Notice of Motion and the materials filed by the Applicants in support of this Notice of Motion is hereby

abridged, such that this application is properly returnable on January 5, 2010 and further service thereof on any other person shall be dispensed with.

- B. An Order authorizing the Applicants to file with this Honourable Court a plan of compromise or arrangement between the Applicants and their creditors, as such plan may be amended from time to time (the "**Plan**").
- C. An Order authorizing and directing the Applicants to convene and conduct a meeting of their creditors (the "**Creditors' Meeting**") to consider and vote upon the Plan and approving the form of materials to be distributed by the Applicants to their creditors in connection with the Creditors' Meeting.
- D. An Order directing that, upon approval of the Plan by the majorities of the creditors of the Applicants required pursuant to section 6 of the CCAA, the Applicants shall commence and prosecute an application for an Order of this Honourable Court sanctioning the Plan (the "**Sanction Order**"), such application to be heard by the Honourable Mr. Justice N.G. Gabrielson at the Court House, 520 Spadina Crescent East, Saskatoon, Saskatchewan at 9:00 a.m. (Central Standard Time) on Thursday, February 11, 2010.
- E. An Order providing that the Initial Order, the stay of proceedings against the Applicants by their creditors contained in the Initial Order and the period of time during which the Applicants shall be permitted to file one or more plans of compromise or arrangement with their creditors shall be and are hereby extended to and including 11:59 p.m. Central Standard Time on Thursday, February 11, 2010.
- F. Such further and other relief as counsel may request and this Honourable Court may deem just and appropriate.

AND FURTHER TAKE NOTICE THAT the grounds to be argued in support of this application are as follows:

- 1. The Applicants have developed and prepared the Plan and they propose to present the Plan to their creditors.

2. The Applicants propose to convene a meeting of their creditors to consider the Plan at 10:00 a.m. (Central Standard Time) on Monday, February 8, 2010.
3. In the event that the Plan receives approval at the Creditors' Meeting from the majorities of the creditors of the Applicants required under section 6 of the CCAA, the Applicants intend to commence and prosecute an application to this Honourable Court for court sanction of the Plan, such application to be heard by the Honourable Mr. Justice N.G. Gabrielson at 9:00 a.m. (Central Standard Time) on Thursday, February 11, 2010.
4. An extension of the stay of proceedings from February 1 to February 11, 2010 is required, in order to permit the creditors of the Applicants to consider and vote upon the Plan.

AND FURTHER TAKE NOTICE THAT the materials to be relied upon in support of this application are as follows:

- (a) this Notice of Motion;
- (b) a form of Draft Order;
- (c) the Second Report of the Monitor;
- (d) the Fifth Supplementary Affidavit of Canute Tagseth;
