UPON THE EX PARTE APPLICATION of the Applicants, Big Sky Farms Inc., Drycast Systems Inc. and Big Sky Management Consulting Corp. (collectively, the "**Applicants**" or "**Big Sky**"), and upon having read the Memorandum to the Presiding Judge dated March 12, 2010 (the "**March 12, 2010 Memorandum to the Presiding Judge**") and the Draft Order, all filed:

IT IS HEREBY ORDERED THAT:

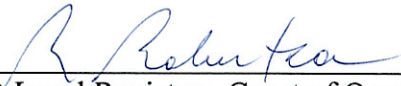
1. The proposed Eighth Supplementary Affidavit of Canute Tagseth to be filed on behalf of the Applicants (the "**Eighth Supplementary Tagseth Affidavit**"), to which Eighth Supplementary Tagseth Affidavit the Applicants propose to exhibit those 23 documents comprising 22 hog finishing contracts (the "**Finishing Contracts**") and one appraisal of assets of the Applicants (the "**Appraisal Report**"), all as more particularly described in Schedule "A" to the March 12, 2010 Memorandum to the Presiding Judge (collectively, the

"Confidential Documents"), shall be held on the Court File in a sealed envelope until further Order of the Court, and, no person, other than the Honourable Mr. Justice N.G. Gabrielson, the Monitor, Big Sky and their respective counsel, shall be permitted to view, copy, reproduce or have access to the Eighth Supplementary Tagseth Affidavit unless such person first obtains an Order of this Honourable Court permitting access to the Eighth Supplementary Tagseth Affidavit (with any such application to be commenced on three clear days' notice to the Applicants and to the Monitor).

2. Any party subsequently making reference to any one of the Confidential Documents shall do so only by using the corresponding defined term for such Confidential Document set out in Schedule "A" to the March 12, 2010 Memorandum to the Presiding Judge and in a manner that does not identify the parties to the Finishing Contracts (other than Big Sky Farms Inc.) and does not identify values of individual assets described in the Appraisal Report.
3. The sealed envelope containing the Confidential Documents shall, when filed with this Court, bear a label reading as follows:

"STRICTLY CONFIDENTIAL—SEALED BY ORDER OF THIS COURT. NO PERSON SHALL VIEW, EXAMINE, COPY OR REPRODUCE THE CONTENTS OF THIS ENVELOPE WITHOUT FIRST OBTAINING AN ORDER OF THE COURT OF QUEEN'S BENCH FOR SASKATCHEWAN GRANTING SUCH PERSON ACCESS TO THE CONTENTS OF THIS ENVELOPE".
