is required to fix the hearing of the motion of Woodbridge (Proceeding 876):

1. The additional affidavit of Woodbridge, as well as any other exhibits that Woodbridge intends to use at the hearing in addition to those filed in the record, will be communicated to Abitibi and filed in the Court record at the latest on February 11<sup>th</sup>, 2011;

2. Abitibi's contestation, as well as any exhibits Abitibi intends to use at the hearing, will be communicated and filed in the Court record at the latest on February 18<sup>th</sup>, 2011;

3. Counsel for both parties will file in the record, a joint letter signed by both of them indicating the list of all witnesses they expect to present at the hearing, with an indication of the length of the examination and the length of cross-examination for each, as well as an indication of the length of arguments expected by both counsel, at the latest on February 25<sup>th</sup>, 2011;

Once these steps are completed, to the satisfaction of the Court, the Court assistant will communicate with counsel to offer dates in order to fix the hearing of the motion. At the moment it is expected that the hearing should last between 1 to 1 1/2 days, evidence and arguments included. In terms of written outline of arguments, the Court will specify once the hearing dates are fixed the deadline in
