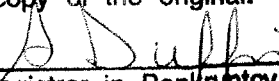

BANKRUPTCY ORDER

On the application of Royal Bank of Canada, creditor, of Edmonton, in the
Province of Alberta, filed on the 6th day of October, 2010;

Having heard counsel on behalf of the Application Creditor;

And having seen the exhibits;

And it appearing to the court that the following acts of bankruptcy have been
committed:

A. North Paw Energy Services Ltd. has failed to meet its liabilities generally as
they became due.

1. The Court hereby orders that North Paw Energy Services Ltd. be adjudged
bankrupt by virtue of a bankruptcy order hereby made on this date.
2. The Court further orders that Ernst & Young Inc. of Calgary, Alberta, be
appointed as trustee of the estate of the bankrupt.
3. The Court further orders that the trustee give security in cash or by bond without
delay, in accordance with subsection 16(1) of the Act.
4. The Court further orders that the costs of the Application Creditor be paid out of
the estate of the bankrupt on taxation of the estate.

5. The Court further orders that service of the Application and Affidavit of Truth is deemed good and sufficient and the time for service of the Application and Affidavit of Truth is abridged to the time actually given and any further service is dispensed with.
