**APPROVAL AND VESTING ORDER
(re C.M. Dickison & Sons Ltd.)**

THIS MOTION, made by Ernst & Young Inc. in its capacity as Court-appointed receiver and receiver manager of the property, assets and undertakings of the Respondents (the "**Receiver**") for an order: (a) authorizing and directing the Receiver to complete the sale to C.M. Dickison & Sons Ltd. ("**CM Dickison**") of the assets identified Parcel 5.1A, Parcel 5.1B and Parcel 5.8 in the Tender Process and Tender Information Package approved by the Order of The Honourable Mr. Justice Riordon granted in these proceedings dated July 28, 2010 and listed on **Schedule "A"** hereto (collectively, the "**Purchased Assets**"), the sale of which is contemplated by the tender submitted by CM Dickison (the "**CM Dickison Tender**") and appended to the Supplement to the Seventh Report dated September 24, 2010 (the "**Supplemental Report**"); and (b) vesting in CM Dickison the right, title and interest of the Respondents in and to the Purchased Assets, was heard this day at 673 King George Highway, Miramichi, New Brunswick.

ON READING the Seventh Report of the Receiver dated September 24, 2010 and the appendices attached thereto, the Supplemental Report and the appendices attached thereto, and the Receiver's Record on Motion, and on hearing the submissions of counsel for the Receiver, The Bank of Nova Scotia, the Province of New Brunswick, Aviva Surety, Caterpillar Financial Services Limited and General Electric Canada Equipment Financing G.P. and related entities,

1. **THIS COURT ORDERS AND DECLARES** that the CM Dickison Tender for the Purchased Assets is hereby approved and the acceptance of the CM Dickison Tender by the Receiver is hereby authorized and approved. The Receiver is hereby authorized and directed to complete the sale of the Purchased Assets to CM Dickison and to take such additional steps and execute such additional documents as may be necessary or desirable for the conveyance of the Purchased Assets to CM Dickison.

2. **THIS COURT ORDERS AND DECLARES** that upon the delivery of a Receiver's certificate to CM Dickison substantially in the form attached as **Schedule "B"** hereto (the "**Receiver's Certificate**"), all of the Respondents' right, title and interest in and to the Purchased Assets described in the CM Dickison Tender shall vest absolutely in CM Dickison, free and clear of and from any and all security interests (whether contractual, statutory, or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory, or otherwise), liens, executions, levies, charges, or other financial or monetary claims, whether or not they have

attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "**Claims**") including, without limiting the generality of the foregoing: (i) any encumbrances or charges created by Orders of The Honourable Mr. Justice Riordon granted in these proceedings; (ii) any encumbrances or charges created by Orders of The Honourable Mr. Justice Riordon granted in proceedings bearing Court File No. N/M/16/10, (iii) all charges, security interests or claims evidenced by registrations pursuant to the *Personal Property Security Act* (New Brunswick), the *Land Titles Act* (New Brunswick), the *Registry Act* (New Brunswick) or any other personal property or real property registry system (all of which are collectively referred to as the "**Encumbrances**") and, for greater certainty, this Court orders that all of the Encumbrances affecting or relating to the Purchased Assets are hereby expunged and discharged as against the Purchased Assets.

3. **THIS COURT ORDERS** that notwithstanding this Court Order and despite paragraph 2 of this Order, easements and rights of way and such other interests including prescriptive interests shall continue with respect to the Real Property (as defined herein).

4. **THIS COURT ORDERS** that upon the registration under the *Land Titles Act* (New Brunswick) of a transfer for the Real Property by the Receiver, the Land Registrar is hereby directed to enter CM Dickison as the owner in fee simple of real property municipally known as 626 Newcastle Blvd., Miramichi (PID 40489437, PID 40127862, PID 40177131, PID 40277873, PID 40175622 and PID 40277881) (collectively, the "**Real Property**"), and is hereby directed to delete and expunge from title to the Real Property all of the Claims and Encumbrances listed on title to the Real Property.

5. **THIS COURT ORDERS** that for the purposes of determining the nature and priority of Claims, the net proceeds from the sale of the Purchased Assets shall stand in the place and stead of the Purchased Assets, and that from and after the delivery of the Receiver's Certificate all Claims and Encumbrances shall attach to the net proceeds from the sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale, as if the Purchased Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale.

6. **THIS COURT ORDERS AND DIRECTS** the Receiver to file with the Court a copy of the Receiver's Certificate, forthwith after delivery thereof.

7. **THIS COURT ORDERS** that, notwithstanding:

- (a) the pendency of these proceedings;
- (b) any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy and Insolvency Act* (Canada) in respect of the Respondents and any bankruptcy order issued pursuant to any such applications; and
- (c) any assignment in bankruptcy made in respect of the Respondents;

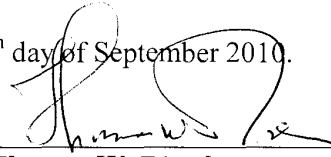
the vesting of the Purchased Assets in CM Dickison pursuant to this Order shall be binding on any trustee in bankruptcy appointed in respect of the Respondents and shall not be void or voidable by creditors of the Respondents, nor shall it constitute nor be deemed to be a settlement, fraudulent preference, assignment, fraudulent conveyance, transfer at undervalue or other reviewable transaction under the *Bankruptcy and Insolvency Act* (Canada) or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

8. **THIS COURT HEREBY REQUESTS** the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.

9. **THIS COURT ORDERS** that any party that has received notice of the Seventh Report and the Receiver's Record on Motion may apply to this Court to vary or amend this Order by serving a notice of motion requesting such relief on the parties recorded on the service list maintained by the Receiver in these proceedings by no later than 5:00 pm AST on Friday October 8, 2010.

RECITALS

A. Pursuant to an Order of The Honourable Mr. Justice Riordon of The Court of Queen's Bench of New Brunswick (the "**Court**") dated March 2, 2010, as amended, Ernst & Young Inc. was appointed as receiver and receiver manager in respect of the property, assets and undertakings of the Respondents (the "**Receiver**").

B. Pursuant to an Order of the Court dated September 29, 2010 (the "**Approval and Vesting Order**"), the Court approved the CM Dickison Tender, authorized and approved the acceptance of the CM Dickison Tender by the Receiver, and provided for the vesting in CM Dickison of the right, title and interest of the Respondents in and to the Purchased Assets, which vesting is to be effective with respect to the Purchased Assets upon the delivery by the Receiver to CM Dickison of a certificate confirming (i) the payment by CM Dickison of the purchase price for the Purchased Assets; (ii) that the conditions to closing as set out in the CM Dickison Tender have been satisfied or waived by the appropriate party; and (iii) the transaction has been completed to the satisfaction of the Receiver.

C. Unless otherwise indicated herein, terms with initial capitals have the meanings set out in the Approval and Vesting Order.

THE RECEIVER CERTIFIES the following:

1. CM Dickison has paid and the Receiver has received the purchase price for the Purchased Assets payable on the closing date pursuant to the CM Dickison Tender;
2. The conditions to closing as set out in the CM Dickison Tender have been satisfied or waived by the Receiver or the appropriate party; and
3. The transaction has been completed to the satisfaction of the Receiver.
