NOTICE OF MOTION

TAKE NOTICE THAT an application will be made on behalf of Ernst & Young Inc. (the "Receiver") in its capacity as the Receiver and Manager of Integra Investment Service Ltd., Aurora River Tower Inc., Carling Spring Village Inc., and Carling Development (B.C.) Inc., (collectively the "Debtors") before the Honourable Madam Justice C.A. Kent in Chambers, at the Calgary Courts Centre, 601 - 5 Street S.W., in the City of Calgary, in the Province of Alberta, on Wednesday the 27th day of February, 2008, at the hour of 2:00 o'clock in the afternoon, or soon thereafter as counsel may be heard, for the following relief:

1. An Order declaring that service of notice of this application and the supporting materials is good and sufficient.
2. An Order approving the Settlement Agreement made between the Receiver and Carling Development Inc., Carling Financial Corporation, Carling Group Canada Inc. (collectively the "Inspectorship Companies"), Danny Cheng and Lisa Wong (the "Settlement Agreement") attached as Appendix A to the Seventh Report of the Receiver dated February 11,

2008 (the "Receiver's Report"), in the form of Order attached as Schedule "B" to the Settlement Agreement, including, but not limited to the following relief:

- (a) Authorizing the Receiver to execute all deeds and documents, and take all such steps as may be necessary or advisable in the sole discretion of the Receiver, to give effect to the Settlement Agreement, and all transactions contemplated therein;
- (b) Treating the Investors of the Inspectorship Companies and Carling Development (B.C.) Inc., using the Pooled Investment Approach;
- (c) Transferring to Carling Development Inc. any claims which the Investors may have against the Debtors and transferring to Carling Development Inc. any claims that Carling Developments (B.C.) Inc. may have against the other Debtors ;
- (d) Relieving the Inspector of its duties and obligations to hold a meeting of Investors in accordance with the Order granted in these proceedings on October 4, 2007, and instead, authorizing and directing the Inspector to convene a meeting of the Investors within thirty days of the granting of the order approving the Settlement Agreement;
- (e) Transferring the Airdrie Lands to the Airdrie Purchaser, or its nominee, in accordance with the Settlement Agreement;
- (f) Vesting the Airdrie Lands in the name of the Airdrie Purchaser, free and clear of any and all estate, right, title, interest, royalty, rental and equity of redemption of any party, except the holders of the Airdrie Permitted Encumbrances, and compelling delivery of the Airdrie Lands to the Airdrie Purchaser for its exclusive possession and enjoyment;
- (g) Directing the Registrar of the South Alberta Land Registration District to cancel all registrations made against the title to the Airdrie Lands, except the Airdrie Permitted Encumbrances;

- (h) Authorizing the Receiver to hold back from the net proceeds of the sale of the Airdrie Lands an amount sufficient to satisfy the claims of the caveator under instrument number 071 069 102, and that such proceeds shall stand in place instead of the Airdrie Lands for the benefit of the caveator;
- (i) Authorizing the Receiver to repay in full the mortgage registered against the Airdrie Lands as mortgage number 021116959;
- (j) Transferring the Fort McMurray Lands to Carling Development Inc. in accordance with the Settlement Agreement;
- (k) Vesting the Fort McMurray Lands in the name of Carling Development Inc., free and clear of any and all estate, right, title, interest, royalty, rental and equity of redemption of any party, except the holders of the Fort McMurray Permitted Encumbrances, and compelling delivery of the Fort McMurray Lands to Carling Development Inc. for its exclusive possession and enjoyment;
- (l) Directing the Registrar of the North Alberta Land Titles Registration District to cancel all registrations against the title to the Fort McMurray Lands, except the Fort McMurray Permitted Encumbrances;
- (m) Confirming and approving the conduct and actions of the Inspector in these proceedings, to the date of the Approval Order, and amending and restating the role of the Inspector after the date of the Approval Order to (i) monitor the business of Carling Development Inc., (ii) terminate all bank accounts of Carling Development Inc. and establish new accounts as may be necessary for the Fort McMurray Project, (iii) establish an accounting of, and maintain the books and records of, the Fort McMurray Project, (iv) engage consultants, appraisers, agents and such other persons as are necessary from time to time, to assist with the exercise of the Inspectors rights and powers, (v) participate with and take direction from the Investors Committee, (vi) serve as chair person of the Investors Committee, (vii) report to and meet with any affected persons in respect of Carling Development Inc. or the Fort McMurray Project, (viii) report to this

Honourable Court, (ix) register a copy of this order against any of the property of Carling Development Inc., including the Fort McMurray Lands, and (x) to take such other steps as are reasonably incidental to the exercise of these powers;

- (n) Discharging the Inspector from its role and duties as Inspector of Carling Financial Corporation and Carling Group Canada Inc.;
- (o) Creating an Investors Committee, and describing its rights and duties;
- (p) Requiring the Inspectorship Companies to cooperate with the Inspector and the Investors Committee, and provide each of them with such information and material as they may reasonably request in the completion of their respective mandates;
- (q) Staying all proceedings against Carling Development Inc., Carling Financial Corporation, Carling Group Canada Inc., Danny Cheng and Lisa Wong, and staying and restraining the exercise of all rights and remedies against each of them, without the leave of this Honourable Court first being obtained;
- (r) Restraining and restricting the directors of Carling Development Inc. from exercising certain powers without the prior written authorization of the Investors Committee;
- (s) Approving and allowing the fees and disbursements (including solicitor and client costs) of the Inspector;
- (t) Creating certain charges against the Fort McMurray Lands including:
 - (i) The Professionals Charge, which secures the fees and disbursements of the Inspector, its legal counsel and legal counsel to Carling Development Inc.;
 - (ii) The Investors Charge, in favour of the Investors of Carling Development Inc., Carling Financial Corporation, Carling Group Canada Inc., and Carling Development (B.C.) Inc.;

- (iii) The Fort McMurray Equity Charge, in favour of the Receiver;
 - (u) Describing the priority of those charges; and
 - (v) Converting the Inspectorship of Carling Development Inc., Carling Financial Corporation, Carling Group Canada Inc., into a new action, to be commenced by the filing of the Approval Order, prescribing a style of cause for that new action, and directing the Clerk of the Court to take the steps necessary to convert the Inspectorship in these proceedings into a new action.
3. And such further and other relief as may be necessary and incidental to the foregoing, or as counsel may advise, and as this Honourable Court may permit.

AND TAKE NOTICE THAT the capitalized terms used herein have the same meaning as ascribed to them in the Settlement Agreement, unless otherwise defined herein.

AND TAKE FURTHER NOTICE THAT the grounds upon which this application will be made include the following:

1. The Receiver was appointed over Debtors, by order of this Honourable Court granted September 8, 2006 (the "Receivership Order").
2. As set out in the Receivership Order, the Receiver has the duty and authority to investigate the business and affairs of the Debtors and report its findings to this Honourable Court, and the Receiver has done so in respect of, *inter alia*, the Settlement Agreement, in its Seventh Report.
3. The Receivership Order authorizes and empowers the Receiver to sell the property of the Debtors, subject to approval of this Honourable Court.
4. The Receivership Order authorizes and empowers the Receiver to settle, extend or compromise any indebtedness owing to or by the Debtors, and also to settle or compromise any proceedings instituted in respect of the Debtors or their property.

5. The Receivership Order authorizes and empowers the Receiver to apply to this Honourable Court for any vesting orders or other orders necessary to convey the Property, or any part thereof, to purchasers.
6. The Receiver has created, implemented and largely completed a Proof of Claims Process as required by the Order granted by this Honourable Court on June 4, 2007.
7. On May 23, 2007, the Inspector was appointed over the Inspectorship Companies by Consent Order.
8. As set out in the Consent Order, the Inspector has the duty and authority to investigate the business and affairs of the Inspectorship Companies and report its finding to this Honourable Court, and the Inspector has done so in respect of, *inter alia*, the Settlement Agreement, in its Second Report.
9. The Inspector has created, implemented and largely completed a proof of claims process as required by the order granted by this Honourable Court on October 4, 2007.
10. The Inspector has convened a meeting of the Fort McMurray Investors, in accordance with the Memorandum of Judgment issued by this Honourable Court on October 18, 2007, and has reported the result of that meeting in its Second Report.
11. The Receiver has concluded that the Settlement Agreement is in the best interests of the stakeholders of the Debtors, and the Inspector has concluded that the Settlement Agreement is in the best interests of the stakeholders, including the Investors, of the Inspectorship Companies, as it:
 - (a) Resolves highly contentious and uncertain litigation between the Debtors and the Inspectorship Companies in a cost effective manner;
 - (b) Creates a return for the estate of the Debtors which might not otherwise be available;
 - (c) Provides a mechanism for the repayment of the Investors of the Inspectorship Companies, which mechanism those stakeholders desire and support;

- (d) Brings certainty to all aspect of the relationship between the Debtors and the Inspectorship Companies;
- (e) Allows the commercial enterprise to proceed; and
- (f) Completes the Carling part of the Debtors' receivership.

12. And such further and other grounds as counsel may advise and this Honourable Court may permit.

AND TAKE FURTHER NOTICE THAT in support of this application will be read the Seventh Report of the Receiver, the Second Report of the Inspector, filed and served herewith, the Orders and pleadings previously granted by this Honourable Court in these proceedings, the Reports of the Receiver and Reports of the Inspector previously filed in these proceedings, and such further and other materials as counsel may advise and this Honourable Court may permit.

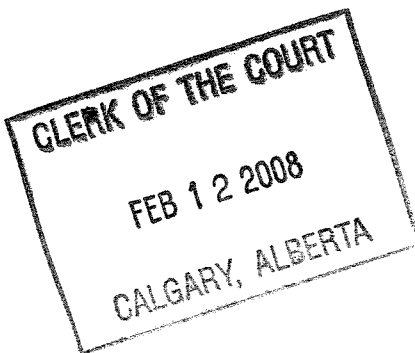
