REPORT OF THE MONITOR – May 23, 2018

INTRODUCTION AND BACKGROUND

1. On February 24, 2010, on a Motion made by Estate WPBC Company (formerly known as White Birch Paper Company and hereinafter referred to as “**WB**”) and various of its affiliates (collectively referred to as the “**Applicants**”), the Superior Court of the Province of Québec for the District of Montréal (“**Court**”), sitting as the designated tribunal pursuant to the *Companies' Creditors Arrangement Act* (“**CCAA**”)¹ issued an order (“**Initial Order**”) declaring that the Applicants are debtor companies to which the CCAA applies, appointing Ernst & Young Inc. as monitor (“**EY**” or “**Monitor**”) and granting certain relief to the Applicants and various partnerships in which the Applicants have an interest (“**Partnerships**”) (the Applicants and the Partnerships are hereinafter referred to collectively as “**WB Canada**”)².
2. Also on February 24, 2010, Estate Bipco LLC (formerly known as Bear Island Paper Company, LLC and hereinafter referred to as “**Bipco**”), a subsidiary of WB with activities in the U.S., commenced a case under the provisions of Chapter 11 of the U.S. *Bankruptcy Code*³ (the “**Code**”) (Bipco and WB Canada are hereinafter referred to collectively as “**WB Group**” or “**Companies**”). The information regarding the proceedings initiated by Bipco under the Code, together with the “first day orders” made by the Bankruptcy Court for the Eastern District of Virginia, Richmond Division (“**U.S. Court**”) at the request of Bipco, can be found on the website of the claims agent retained by Bipco, Garden City Group, Inc., at www.gardencitygroup.com/cases/bip.

3. Also on February 24, 2010, some of the entities within WB Canada⁴ applied for relief under the provisions of Chapter 15 of the Code. On February 26, 2010, the U.S. Court issued a temporary restraining order under the provisions of Chapter 15 of the Code, and on March 5, 2010, it granted a preliminary injunction, pending a more complete hearing to be held on March 22, 2010. At the hearing held on March 22, 2010, the U.S. Court granted recognition of the Canadian proceedings under the CCAA as foreign main proceedings, recognised Estate WBPC Company as the duly appointed foreign representative, declared that all of the provisions of section 1520 of the Code apply to the proceedings initiated by some of the entities within WB Canada, and gave full force and effect to the Initial Order⁵ in the U.S., provided that the Initial Order⁵ is not revoked, terminated or expired.
4. The orders granted by the Court and by the U.S. Court (collectively, the “**Courts**”), together with the relief provided under the CCAA and the Code⁶ (collectively, the “**Orders**”) provide, among other things, for a stay of proceedings against the entities comprising WB Group while they restructure their business and financial affairs.
5. The stay of proceedings has been extended from time to time, and the most recent order extending the stay of proceedings was made on May 27, 2015, and provides for an extension of the stay of proceedings until September 30, 2015. In addition, by order made on June 3, 2015, the Court (*inter alia*) extended the Stay Period⁷ to and including the Effective Date⁸.
6. WB Canada’s plan of compromise (“**Plan**”) was filed on March 17, 2015, was accepted by the creditors at a meeting held on April 22, 2015, and was sanctioned by the Court by judgment rendered June 3, 2015.
7. The present report is intended to provide the Court with information regarding the status of the administration of the Plan and the activities of the Monitor since the date of sanction of the Plan by the Court, on June 3, 2015.

TERMS OF REFERENCE AND DISCLAIMER

8. The Monitor has prepared several reports since the commencement of the restructuring proceedings pursuant to the CCAA, each of which is accessible on the Monitor’s website at www.ey.com/ca/WhiteBirch. This 43rd report should be read in conjunction with the previous reports (this 43rd report and the previous reports are collectively referred to herein as the “**Reports**”).
9. In preparing these Reports and making the comments therein, the Monitor has been provided with, and has relied upon, certain unaudited, draft and/or internal financial information, company records,

management prepared financial information and projections, discussions with employees and representatives of WB, and information from other third party sources (collectively, the “**Information**”).

The Monitor has assumed the integrity and truthfulness of the Information and explanations provided to the Monitor, within the context in which they were presented. To date, nothing has come to the attention of the Monitor that would cause it to question the reasonableness of this assumption.

Finally, the Monitor has requested that the Applicants bring to its attention any significant matters that were not otherwise addressed in the course of its specific inquiries. Accordingly, the Reports are based solely on the Information (financial or otherwise) provided to the Monitor.

Except as described in the Reports, the Monitor has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. The Monitor has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with generally accepted assurance standards or generally accepted standards for review engagements and, accordingly, the Monitor expresses no opinion or other form of assurance in respect of the Information.

In view of the purpose of the Reports, some of the financial information therein may not comply with generally accepted accounting principles.

Some of the information referred to in the Reports consists of forecasts and projections that were prepared based on the Applicants’ estimates and assumptions. Such estimates and assumptions are, by their nature, not ascertainable and as a consequence, no assurance can be provided regarding any such forecasted or projected results. Actual results will vary from the forecasts or projections, even if the estimates and assumptions are accurate, and the variations could be significant.

The Monitor has prepared this 43rd report in its capacity as the Court-appointed Monitor in the proceedings referred to in paragraph 1 hereinabove in order to provide additional information to the Court in connection with the proceedings to date. This report is not appropriate for any other purpose and, consequently, it should not be used for any other purpose.

10. Terms not otherwise defined herein shall have the meaning ascribed to them in the Initial Order, or in previous reports of the Monitor, as the case may be.

STATUS OF PLAN

11. WB Canada’s plan of compromise (“**Plan**”) was filed on March 17, 2015 and was accepted by the creditors at a meeting held on April 22, 2015.
12. On June 3, 2015, a judgment was rendered in which the Court (*inter alia*) sanctioned the Plan, approved the Estate Allocation Compromise and Settlement Agreement (“**EACSA**”), extended the Stay Order until the Effective Date, authorized and Approved the Releases as provided for in the Plan and approved the actions and conduct of the Monitor.
13. The Monitor was informed that all conditions precedent for the implementation of the Plan were satisfied or waived as of July 28, 2015. Accordingly, the Monitor prepared and filed a certificate, to document the fact that the Effective Date occurred on July 28, 2015.

14. As contemplated in the Plan, an initial distribution was sent out to creditors in the week of August 24, 2015. The following information relates to this initial distribution:
 - 14.1. A total of 680 cheques were issued to creditors with ordinary unsecured claims totalling \$1,021,928,052.61. The total amount distributed represented \$54,429,306.89, or 5.33% of the proven claims admitted for distribution purposes.
 - 14.2. A reserve was held back in the amount of \$961,268.01, in respect of claims that had not yet been fully determined. This reserves pertains substantially to the claims of the Canada Revenue Agency (“CRA”) and the Quebec Revenue Agency (“QRA”), which were filed for amounts totalling \$18,027,527.70. The claims from CRA and QRA are addressed later in this report.
 - 14.3. The issuance of cheques triggered notification to the Monitor that certain claims had been assigned and transferred and were no longer payable to the original claimants, resulting in the return and replacement of cheques totalling \$145,831.08.
 - 14.4. As well, several cheques were returned because the address of the claimants as indicated on their proofs of claim was no longer valid or because the claimant was bankrupt or otherwise out of business and not reachable.
 - 14.5. The Monitor has made on-going efforts to trace the claimants or the assignee or successors of the claimants since the first distribution. These efforts have included primarily performing on-line searches, contacting the creditors directly, and coordinating with employees of the entities designated by BDWBI to purchase the assets to find the suppliers’ new coordinates.
 - 14.6. Notwithstanding attempts to trace claimants who had not cashed their share of the distribution, 45 cheques totalling \$193,608.42 have not been cashed, and the cheques have now become stale-dated. These cheques were issued on account of different claims totalling \$3,635,062. A list of the claimants in question is attached as Appendix A.
15. At the time of the first distribution, the claims of CRA and of QRA, representing claimed amounts of \$10,136,499.49 and \$7,891,028.21 respectively, had not yet been accepted, as these claims were based in large part on notices of assessments that had been disputed by WB Canada. The Monitor coordinated with WB Canada’s legal representatives and tax advisors, and negotiations were undertaken with CRA and QRA with a view to settle the claims. A settlement was eventually reached, whereby the claims of CRA and QRA were reduced to \$3,842,805.27 and \$3,697,938.82 respectively, and CRA’s and QRA’s share of the first distribution, in the amount of 5.33% of their allowed claims, was paid from the reserved funds referred to in paragraph 14.2 above.
16. The Monitor expects that the funds available for a second and final distribution will total \$5,291,399⁹, as follows:

17. The Monitor proposes to distribute the remaining funds to the creditors with allowed claims, excluding however from the distribution those creditors with unknown addresses that the Monitor has not been able to trace (with claims of \$3,635,062 as described in paragraph 14.6 above) and creditors whose claim is so small that their entitlement for the second distribution would be less than \$20.

In view of the fact that the allowed claims against WB Canada total \$1,029,480,159.39, the claims of the creditors who would thus be entitled to share in the second and final distribution total \$1,025,506,499, and each creditor's share of the second and final distribution would represent 0.51% of the creditor's claim.

A schedule outlining the results of the first and the proposed second distribution is presented in Appendix C.

RERWBS

18. By judgment rendered on June 3, 2015, the Court ordered that BDWBI pay to the members of the Regroupement des Employés Retraités de White Birch Stadacona ("**RERWBS**") an amount that was offered by BDWBI, in a letter dated May 21, 2015, in exchange for certain releases as contemplated in the said letter. The letter in question contemplates the payment to the members of the RERWBS their *pro rata* share of an aggregate amount of \$745,055 ("**Fund**").
19. The form of release was distributed to RERWBS and the forms executed by the members of the RERWBS were returned to BDWBI. A schedule was provided by BDWBI to RERWBS to indicate each member's *pro rata* share of the Fund.
20. Before the distribution was made, a question arose regarding the possible obligation of BDWBI to withhold payroll source deductions from the proposed payments to the members of the RERWBS. In order to avoid further delays, BDWBI and RERWBS agreed that an initial payment would be made and an amount equivalent to the potential withholding at source would be held back, while BDWBI requested an advanced ruling from CRA regarding whether or not it had an obligation to withhold and remit.

21. The Monitor has been informed that the ruling from CRA suggested that the payments to the members of the RERWBS were subject to payroll source withholdings. The Monitor understands the remaining unpaid amounts were paid to the CRA as withheld amounts for the account of the members of the RERWBS, and that accordingly the obligation of BDWBI pursuant to the judgment rendered June 3, 2015 has been met.

OVERALL COMMENTS AND CONCLUSIONS

22. The Monitor's administration of the funds to be distributed pursuant to the Plan is essentially completed. The Monitor proposes to distribute an additional amount of 0.51% on account of the creditors' allowed claims, bringing distributions to unsecured creditors under the plan to 5.84% of their claims. After this distribution, the Monitor expects that all funds will have been distributed.
23. The Monitor has provided, attached herein as Appendix B, an accounting of the funds that were remitted to the Monitor in connection with the sale of the assets of WB Canada and the EACSA. This accounting provides a complete report of the funds received by the Monitor and the disposition of these funds to date, and the present report addresses the proposed disposition of the remaining funds on hand.
24. The Monitor respectfully requests that the Court approve the accounting submitted by the Monitor and approve the reports and decisions made by the Monitor to date.
25. Finally, the Monitor respectfully requests that the Court approve the final distribution proposed by the Monitor, authorize the Monitor to distribute the funds as contemplated in Appendix C hereof, and discharge the Monitor upon the Monitor filing a final certificate confirming that all funds have been distributed as described in the said Appendix.

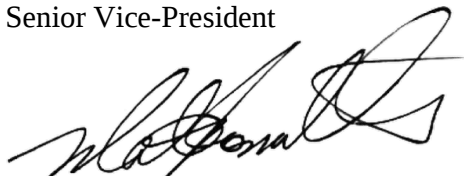
