TAKE NOTICE that Ernst & Young Inc. ("E&Y") in its capacity as the Receiver and Manager (the "Receiver") of Integra Investment Service Ltd., Aurora River Towers Inc., Carling Springs Village Inc. and Carling Development (B.C.) Inc. (the "Integra Companies"), will make an application before the Honourable Madam Justice Kent, in Justice Chambers, at the Calgary Court Centre, in the City of Calgary, in the Province of Alberta on Tuesday, the 11 day of December, 2007 at 1:15 in the afternoon or soon thereafter as counsel may be heard for advice and directions regarding:

- (a) The inclusion of a late claim into the Integra Claims Process;
- (b) The Receiver's recommendations with respect to the proposed distribution methodologies;
- (c) The Receiver's proposed interim distribution.

AND FURTHER TAKE NOTICE that the grounds of the application are as follows:

- (a) By way of an Order dated September 8, 2006, this Honourable Court appointed E&Y as the Receiver and Manager of the Integra;
- (b) The Receiver has filed its Sixth Report and recommends the acceptance of one late claim in an amount of \$7,874.89;

- (c) The Receiver has recommended an interim distribution, particulars of which are set out in the Receiver's Sixth Report;
- (d) To enable the Receiver to make the proposed interim distribution, the Receiver requires advice and directions from the Honourable Court regarding the Receivers recommendations with respect to the proposed distribution methodologies to be used;
- (e) The Receivers Sixth Report is available on the Receivers website, and by a letter dated December 4, 2007 the Receiver has given notice to the creditors and investors of the Integra Companies that the Sixth Report is available on the website and of the date upon which this application will be heard.

AND FURTHER TAKE NOTICE that in support of this application the Receiver will rely upon its First, Second, Third, Fourth, Fifth and Sixth Reports, filed, and such further and other material as counsel may advise and this Honorable court may permit.
