

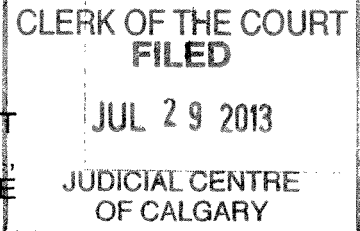

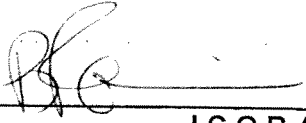
ORDER
