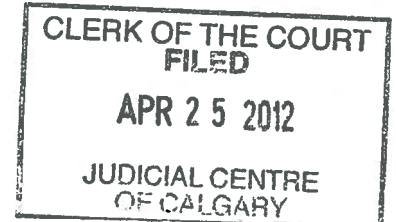

IT IS HEREBY ORDERED THAT:

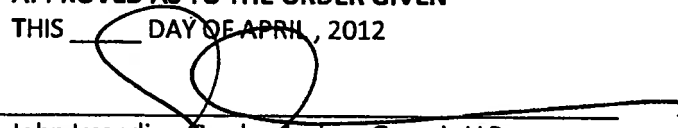
1. The hearing of the Application is adjourned to 2:00 p.m., May 10, 2012 before the Honourable Justice B.E.C. Romaine.

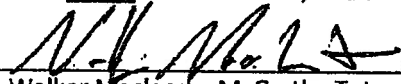

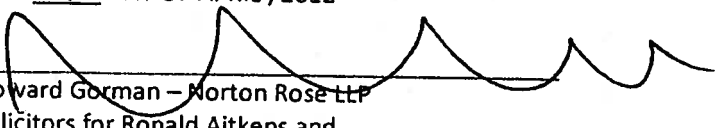
