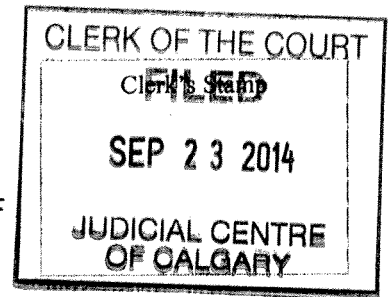

B. Pursuant to an Order of the Court dated May 9, 2014, the Court approved and sanctioned the Plan.

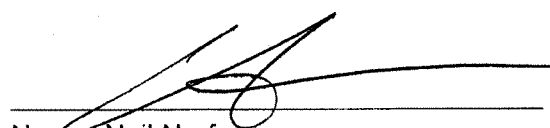
C. Unless otherwise indicated herein, terms with initial capitals have the meanings set out in the Plan.
