**ORDER GRANTING EXPEDITED JOINT MOTION TO PAY CERTAIN
2014 AD VALOREM TAXES**

Ernst & Young, LLP (“EY”), as the court-appointed monitor (the “**Monitor**”) and authorized foreign representative of the above-captioned Debtors, filed its *Expedited Joint Motion to Pay Certain 2014 Ad Valorem Taxes* (“**Motion**”) in the above-styled and numbered chapter 15 cases. The Court finds that notice was proper and that no party in interest made any response in opposition to the Motion or, if so, the relief requested in any such response was denied for the reasons stated on the record, and further finds that the relief requested in the Motion should be granted. It is therefore

ORDERED that the Debtors and Monitor are authorized to pay Dimmit County \$14,136.36 for 2014 taxes. It is further

ORDERED that the Debtors and Monitor are authorized to pay Spring Branch Independent School District \$1,284.90 for 2014 taxes. It is further

ORDERED that the Debtors and Monitor are authorized to pay the City of Houston \$581.49 for 2014 taxes. It is further

ORDERED that the Debtors and Monitor are authorized to pay the Dimmit Regional Hospital District \$3,073.12 for 2014 taxes. It is further

ORDERED that the Debtors and Monitor are authorized to pay the Wintergarden Groundwater Conservation District \$316.53 for 2014 taxes. It is further

ORDERED that the Debtors and Monitor are authorized to pay Carrizo Springs CISD \$67,743.86 for 2014 taxes.

ORDERED that the above amounts are for the 2014 taxes and interest for the above taxing units payable if paid by June 30, 2015. If such 2014 taxes and interest for the above taxing units are not paid by June 30, 2015, the Debtors and the Monitor are authorized to pay any amounts owed for such 2014 taxes and interest subsequent to June 30, 2015.
