ORDER

(Consolidation of Hollinger Actions)

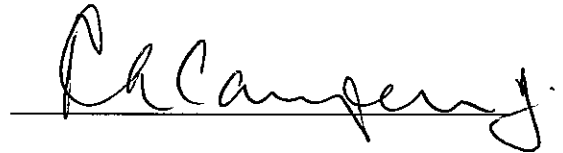
THIS MOTION, made by the Plaintiffs, for an Order consolidating the proceedings bearing Court File Numbers 06-CL-6261, 05-CL-5822 and 07-CL-6954 was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Motion Record of the Plaintiffs, and on being advised that no parties object to the relief sought therein although duly served,

1. **THIS COURT ORDERS** that the time for service of this motion be and is hereby abridged, all parties having advised the Court that no one objects to the relief sought.
2. **THIS COURT ORDERS** that the proceedings bearing Court File Numbers 06-CL-6261, 05-CL-5822 and 07-CL-6954 (together the “**Hollinger Actions**”) be consolidated and heard together in one proceeding.
3. **THIS COURT ORDERS** that the proceeding bearing Court File No. 06-CL-6261 (the “**Main Action**”) be deemed the lead action in this consolidated proceeding for the purposes of court filings.
4. **THIS COURT ORDERS AND DECLARES** that the allegations set out under the Main Action (along with the defences thereto once delivered) will form the foundation for the scope of all discoveries and document production required in that proceeding as well as the proceedings bearing Court File Numbers 05-CL-5822 and 07-CL-6954 (the “**Other Hollinger Actions**”).
5. **THIS COURT ORDERS AND DECLARES** that, to the extent that defendants to the Main Action are also defendants to the Other Hollinger Actions, statements of defence responsive to the Main Action will be deemed to be in answer to the Other Hollinger Actions as well, such that only one statement of defence from each defendant will be required in answer to the Hollinger Actions.
6. **THIS COURT ORDERS AND DECLARES** that nothing in this Order shall be construed as conferring additional claims on the Plaintiffs beyond those already claimed against the defendants in the respective Hollinger Actions in which they are named as

defendants, or which could subject the defendants to additional claims that are not already alleged in the Hollinger Actions in which they are respectively named as defendants.

7. **THIS COURT ORDERS AND DECLARES** that nothing in this Order shall be construed as abridging or extending any times or limitation periods relevant to the claims in issue in the respective Hollinger Actions.
