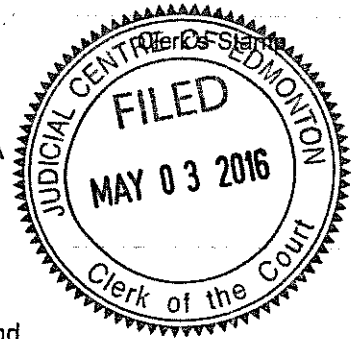

UPON THE APPLICATION of the Receiver, Ernst & Young Inc. (the "Receiver"); AND UPON HAVING READ the Third Report of the Receiver filed April 26, 2016; AND UPON HEARING representations from counsel for the Receiver; AND UPON HEARING representations from counsel for Farm Credit Canada and Agriculture Financial Services Corporation; IT IS HEREBY ORDERED THAT:

1. Service of this application upon the interested parties is hereby validated and abridged.
2. The Receiver's proposed sales and marketing process for assets of Growing Power Management Ltd. and Growing Power Hairy Hill Limited Partnership is hereby approved.
3. The Receiver's plan to deal with confidentiality issues of third party information in the sales and marketing process of the assets by use of a Non-Disclosure and Confidentiality Agreement in a form similar to that contained in the Receiver's Third Report in the marketing of the assets of

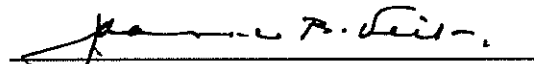
Growing Power Management Ltd. and Growing Power Hairy Hill Limited Partnership is hereby approved.

4. The sale of certain non-essential assets by the Receiver which assets are as follows:
- a) 2009 Dodge Caravan bearing Serial Number 2D8HN44E19R506829 for \$7,700.00;
 - b) 2007 Ford Ranger bearing Serial Number 1FTZR45E47PA19578 for \$1,250.00;
