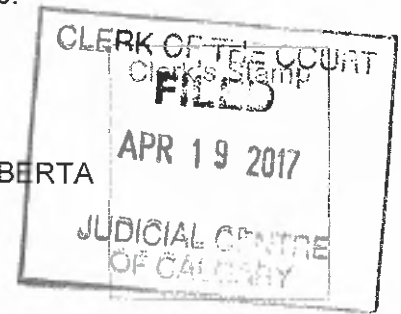

UPON the application of Connacher Oil and Gas Limited (the "**Applicant**" or "**Connacher**"); **AND UPON** having read the Application, the Affidavit No. 8 of Merle Johnson sworn on April 10, 2017 (the "**Johnson Affidavit**"), the Eighth Report of Ernst & Young Inc., the Court-appointed monitor of the Applicant (the "**Monitor**"), and the pleadings and proceedings herein, including the Initial Order granted on May 17, 2016 (the "**Initial Order**"); **AND UPON** hearing counsel for the Applicant, the Monitor and the Interim Financing Agent and First Lien Agent (as each defined in the Initial Order), and counsel for the other interested parties appearing;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. The time for service of the notice of application for this order is hereby abridged and deemed good and sufficient, no other person is required to have been served with notice of this application and this application is properly returnable today.
2. Capitalized terms used in this Order but not defined shall have the same meaning given to them in the Settlement Agreement, as defined below.
3. The minutes of settlement between Connacher and IDE Technologies Ltd. ("**IDE**") dated April 9, 2017 as attached at Exhibit "D" to the Johnson Affidavit (the "**Settlement Agreement**") is hereby approved, and Connacher is hereby authorized and directed to perform its obligations under the Settlement Agreement including, without limitation, executing and filing a Discontinuance of Claim in the action commenced in the Court of Queen's Bench of Alberta Action No. 1601-07421 and executing the Mutual Release with IDE in accordance with the terms of the Settlement Agreement.
4. Any disputes in connection with the Settlement Agreement shall be determined by this Court on application, on not less than 7 days' notice, by either Connacher or IDE.
