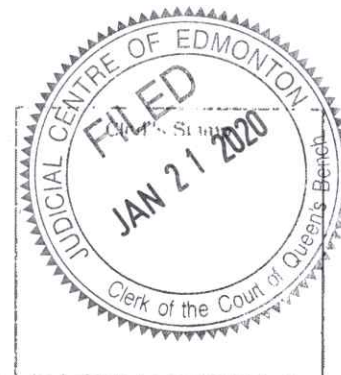

- [4] This Order may be signed in counterpart, and delivered by facsimile or other electronic means.

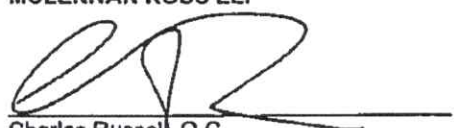

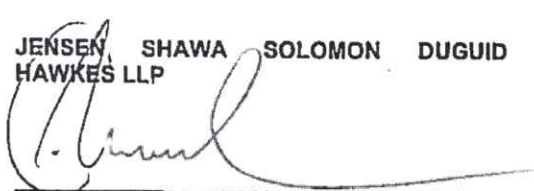

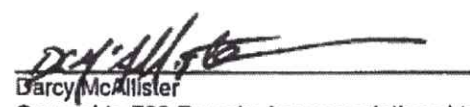
