

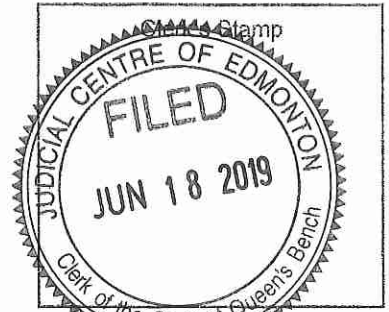

(the "185 Lands")

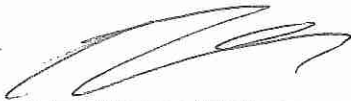
2. All other terms in the original Weslease Mortgages Order shall remain unamended, and in full force and effect.

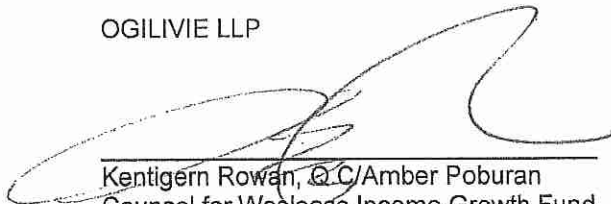
