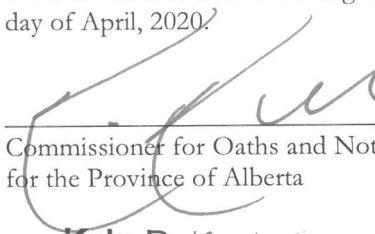
I, Jeline Nantes, of the City of Calgary, in the Province of Alberta, Canada, MAKE OATH AND SAY THAT:
