TRUSTEE'S PRELIMINARY REPORT

SECTION A - BACKGROUND

On August 20, 2020, Home Squad Inc. (the "**Debtor**") made an assignment into bankruptcy.

The Debtor was in the business of selling, installing and servicing recreational housing, with its head office located in Calgary, Alberta.

SECTION B - ASSETS

The following summary represents the Debtor's realizable assets as per its Statement of Affairs:

SECTION C - BOOKS AND RECORDS OF THE BANKRUPT

The Trustee has requested the Debtor's books and records from the Director and expects to receive same in due course.

SECTION D - CONSERVATORY AND PROTECTIVE MEASURES

The Trustee contacted the Canada Revenue Agency (the "CRA"), with respect to their priority claim over the assets of the Debtor, to discuss their intentions with respect to collecting the assets. The Trustee is waiting on a response.

In the meantime, the Trustee contacted the landlord of the Debtor and notified them of the bankruptcy, that the Trustee was not going to be occupying the premises, and the priority claim over the assets by the CRA. The Trustee confirmed with the landlord that they had changed the locks to the premises and asked that the landlord continue to safeguard the assets until contacted by the CRA.

The Trustee notified all third parties, namely the former employees of the Debtor, in possession of the Debtor's assets of the bankruptcy and the priority claim over the assets by the CRA. The Trustee asked the third parties to store the assets in a safe place until contacted by the CRA.

The Trustee notified the insurer of the assets of the Debtor of the bankruptcy and confirmed that all the assets were currently insured until the policy renewal date of September 27, 2020. The Trustee has asked for an estimate of the cost to continue to insure the remaining assets past the renewal date and is waiting on a response.

The Trustee advises that all the assets of the Debtor are in the possession of either the landlord or former employees of the Debtor, except for two trailers located in remote locations in Northern Alberta and Saskatchewan. The Trustee has not taken possession of these assets as the cost of doing so would far outweigh the fair market value ("FMV") of the assets.

Based on the estimated FMV of all the assets and the fact that the assets are spread out over multiple locations in Alberta and Saskatchewan, the Trustee did not feel it economically prudent to the estate to incur additional costs in safeguarding the assets.

The Trustee has notified the Debtor's bank of the bankruptcy and has requested that all accounts be closed, including all credit cards, and any funds on deposit be forwarded to the Trustee.

SECTION E - PROVABLE CLAIMS

Attached as Appendix "A" is a summary of the Debtor's liabilities as noted on its Statement of Affairs. There are no proven claims as at the date of this report.

SECTION F - LEGAL PROCEEDINGS / PREFERENCE PAYMENTS

At this time, the Trustee is not aware of any on going legal proceedings initiated by the Debtor, fraudulent conveyances, preferences or transfers at undervalue made by the Debtor.

SECTION G - THIRD-PARTY DEPOSITS OR GUARANTEES

The Trustee received a third-party deposit of \$25,000.00 from Robert Bradley Sander to cover professional fees and any additional costs related to the administration of the Estate.

SECTION H - APPOINTMENT OF RECEIVER

Not applicable.

SECTION I - ANTICIPATED REALIZATIONS AND PROJECTED DISTRIBUTION

The Trustee has yet to determine how it expects to realize on assets but anticipates the value of the assets to be insufficient to cover the secured liabilities. As such, it is unlikely that there will be any distributions to secured creditors.

SECTION J - OTHER MATTERS

The Trustee is not aware of any other matters affecting the Estate, however, if anyone is aware of matters that should be brought to the attention of the Trustee for further review and investigation, please contact the Trustee's office with supporting details and copies of any available documentation.

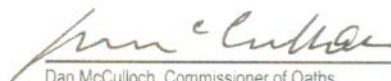
