

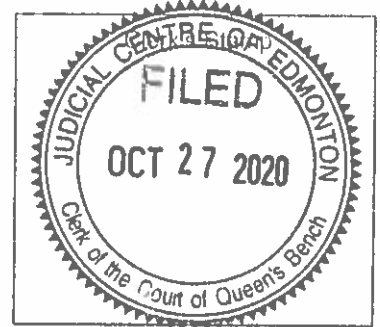

UPON THE APPLICATION of Ernst & Young Inc. in its capacity as the Court-appointed Monitor (the "Monitor") of 667402 Alberta Ltd., 18512398 Alberta Ltd., 816956 Alberta Ltd., 1371047 Alberta Ltd., 1919209 Alberta Ltd. and Canada North Group LP Holdings Ltd. (collectively the "Debtor"), for an order extending the stay of proceedings in this matter to January 31, 2021; AND UPON HAVING READ the pleadings and materials filed herein and

reviewing the Monitor's 29th Report and Confidential Supplement to the Monitor's 29th Report; AND UPON it appearing that service of this Application was effected on the service list for this matter; AND UPON HEARING the submissions of counsel for the Monitor and counsel for Canadian Western Bank and others appearing; IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE
