**CORRECTED APPROVAL AND VESTING ORDER**

---

[1] **ON READING** the Applicant's Application for the Issuance of an Approval and Vesting Order with respect to the disposal of the Debtor's assets and the enforcement of super-priority rights (the "**Motion**"), the affidavit and the exhibits in support thereof, as well as the 13<sup>th</sup> Report of the Monitor dated April 29, 2021, (the "**Report**");

[2] **WHEREAS** on June 9, 2015, this Court issued an initial order with respect to Strateco Resources Inc. (the “**Debtors**”) pursuant to the *Companies’ Creditors Arrangement Act* (the “**CCAA**”) appointing Ernst & Young Inc. as monitor (the “**Monitor**”) providing an initial thirty-day period (the “**Stay Period**”) and other relief (as amended and restated thereafter, the “**Initial Order**”);

[3] **WHEREAS** the Stay Period was extended by way of different Orders of this Court and is set to expire on April 30th, 2021;

[4] **WHEREAS** on October 23, 2015, this Court issued its second amended and restated initial order which created in favour of **the Applicant** an Interim Lender Charge (together with the Administration Charge and the Directors’ Charge, the “**CCAA Charges**”) charging all of the Debtor’s assets;

[5] **WHEREAS** the stated purpose of these proceedings was to fund litigation against the Government of Quebec, which proceedings were funded by the Applicant and which were dismissed by way of judgement dated June 21, 2017, as confirmed on January 13, 2020, with leave to appeal before the Supreme Court of Canada denied;

[6] **WHEREAS** **the Applicant** is no longer willing to fund these CCAA proceedings and the same no longer serve any valid purpose;

[7] **SEEING** the service of the Motion; and

[8] **SEEING** the submissions of the Applicant, the Debtor and the Monitor’s attorneys.

**FOR THESE REASONS, THE COURT HEREBY:**

[9] **GRANTS** the Motion.

[10] **ORDERS** that all capitalized terms in this Order shall have the meanings given to them in the Initial Order unless otherwise indicated herein.

[11] **ORDERS AND DECLARES** that any prior time period for the presentation of this Motion is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further service thereof;

[12] **PERMITS** service of this Order at any time and place and by any means whatsoever.

**DISPOSITION OF ASSETS AND ENFORCEMENT OF SUPER-PRIORITY RIGHTS APPROVAL**

[13] **ORDERS AND DECLARES** that the transfer and vesting of all of the Debtor's right, title and interest in the assets specifically listed on **Schedule "A"** attached hereto (the "**Debtor's Assets**"), in favour of 12942534 Canada Ltd. is hereby approved;

**AUTHORIZATION**

[14] **ORDERS AND DECLARES** that this Order shall constitute the only authorization required by the Debtor to proceed with the Transaction and that no other approval or authorization, including any board or shareholder approval, shall be required in connection therewith.

**EXECUTION OF DOCUMENTATION AND FURTHER STEPS**

[15] **AUTHORIZES AND DIRECTS** the Debtor or the Monitor to take such other steps and to sign such instruments of transfer and other documents as are necessary or useful to give full and complete effect to this order and the transfer of the Debtors Assets to 12942534 Canada Ltd.;

**VESTING OF THE DEBTOR'S ASSETS**

[16] **ORDERS AND DECLARES** that upon the issuance of the Monitor's certificate substantially in the form appended as **Schedule "B"** hereto (the "**Monitor's Certificate**"), all right, title and interest in and to the Debtor's Assets shall vest absolutely and exclusively in and with 12942534 Canada Ltd., free and clear of and from any and all right, titles, benefits, priorities, claims (direct, indirect, absolute or contingent), liabilities, obligations, interests, prior claims, security interests (whether contractual, statutory or otherwise), liens, charges, hypothecs, mortgages, pledges, trusts, deemed trusts (whether contractual, statutory, or otherwise), assignments, judgments, executions, writs of seizure or execution, notices of sale, options, agreements, rights of distress, legal, equitable or contractual setoff, adverse claims, levies, taxes, disputes, charges , options to purchase, rights of first refusal or other pre-emptive rights in favour of third parties, restrictions on transfer of title, or other claims or encumbrances, whether or not they have attached or been perfected, registered, published or filed and whether secured, unsecured or otherwise (collectively, the "**Encumbrances**"), including without limiting the generality of the foregoing all charges, security interests or charges evidenced by registration, publication or filing pursuant to the Civil Code of Québec, or any other applicable legislation providing for a security interest in personal or movable property, and, for greater certainty, **ORDERS** that all of the Encumbrances affecting or relating to the Debtor's Assets, be expunged and discharged as against the Debtor's Assets, in each case effective as of the applicable time and date of the Monitor's Certificate;

[17] **ORDERS AND DECLARES** that upon presentation of the Monitor's Certificate and a certified copy of this Order, accompanied by the required application for assignment and payment of the prescribed fees, that leases 216996 00 002 and 284 10 000 with the

Ministère de l'Énergie et des Ressources Naturelles be assigned in favour of 12942534 Canada Ltd;

[18] **ORDERS AND DECLARES** that upon presentation of the Monitor's Certificate and a certified copy of this Order, accompanied by the required application for assignment, that the authorizations issued by the Ministère de l'Environnement et de la Lutte contre les changements climatiques under numbers 400702115 and 400721880 be assigned in favour of 12942534 Canada Ltd, the whole as provided for by section 31.0.2 of the *Environment Quality Act*, CQLR c. Q-2;

[19] **DECLARES** that upon issuance of the Monitor's Certificate, the disposition of assets shall be deemed to constitute and shall have the same effect as a sale under judicial authority as per the provisions of the *Code of Civil Procedure* and a forced sale as per the provisions of the *Civil Code of Quebec*.

[20] **ORDERS AND DIRECTS** the Monitor, upon receipt of (i) satisfactory evidence that the assignment of the super-priority rights of the Applicant in favour of 12942534 Canada Ltd. has been effected and completed, (ii) payment in full of outstanding post-filing claims payable to the Monitor, its counsel, the Debtor and its counsel, if any (ii) of the applicable Cure Costs payable by the Applicant, to (a) issue forthwith the Monitor's Certificate concurrently to the Applicant, the Debtor and 12942534 Canada Ltd.; and (b) file forthwith after issuance thereof a copy of the Monitor's Certificate with the Court.

#### **TRANSFERS AND CANCELLATION OF SECURITY REGISTRATIONS**

[21] **ORDERS** the Registrar appointed by the Minister of Natural Resources and Wildlife pursuant to the *Mining Act*, R.S.Q. c. M-13.1, upon presentation of the Monitor's Certificate and a certified copy of this Order accompanied by the required application for registration and upon payment of the prescribed fees, to publish this Order and to make an entry or entries showing 12942534 Canada Ltd. as the owner of the mining claims and mineral rights of the Debtor, listed in **Schedule "A"**.

[22] **ORDERS** the Registrar of the Register of Personal and Real Movable Rights to discharge any Encumbrances against the Debtor's (Ressources Strateco inc.) Assets, including the CCAA Charges, registered under the following registration numbers:

[23] **ORDERS** the Registrar of the Register of Real Rights of State Resource Development at the Registry Office for the Registration Division of Lac-St-Jean Ouest upon presentation of the Monitor's Certificate and a certified copy of this Order accompanied by the required application for registration and upon payment of the prescribed fees, to publish this Order and (i) to make an entry or entries showing 12942534 Canada Ltd. as the owner of the mining claims and mineral rights listed in Schedule "A".

#### **VALIDITY OF THE ASSIGNMENTS, TRANSFERS AND VESTING**

[24] **ORDERS** that notwithstanding:

- a) the pendency of the proceedings under the CCAA;
- b) any assignment in bankruptcy or any petition for a bankruptcy order now or hereafter issued pursuant to the BIA and any order issued pursuant to any such petition;
- c) any application for receivership order; or
- d) the provisions of any federal or provincial legislation;

the vesting of the Debtor's Assets contemplated in this Order is to be binding on any trustee in bankruptcy or receiver that may be appointed, and shall not be void or voidable nor deemed to be a preference, assignment, fraudulent conveyance, transfer at undervalue or other reviewable transaction under the *Bankruptcy and Insolvency Act* or any other applicable federal or provincial legislation, as against the Debtor, the Applicant, 12942534 Canada Ltd. or the Monitor, and shall not constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

#### **LIMITATION OF LIABILITY**

[25] **DECLARES** that, subject to other orders of this Court, nothing herein contained shall require the Monitor to take control, or to otherwise manage all or any part of the Debtor's Assets. The Monitor shall not, as a result of this Order, be deemed to be in possession of any of the Debtor's Assets within the meaning of environmental legislation, the whole pursuant to the terms of the CCAA.

**GENERAL**

[26] **DECLARES** that this Order shall have full force and effect in all provinces and territories in Canada.

[27] **DECLARES** that the Monitor shall be authorized to apply as it may consider necessary or desirable, with or without notice, to any other court or administrative body, whether in Canada, the United States of America or elsewhere, for orders which aid and complement this Order. All courts and administrative bodies of all such jurisdictions are hereby respectfully requested to make such orders and to provide such assistance to the Monitor as may be deemed necessary or appropriate for that purpose.

[28] **REQUESTS** the aid and recognition of any court or administrative body in any Province of Canada and any Canadian federal court or administrative body and any federal or state court or administrative body in the United States of America and any court or administrative body elsewhere, to act in aid of and to be complementary to this Court in carrying out the terms of this Order.

[29] **DECLARES** that the Applicant or 12942534 Canada Ltd. may apply for further relief if deemed necessary to give full effect to the assignments and transfers contemplated by this Order.

[30] **ORDERS** the provisional execution of this Order, notwithstanding any appeal and without the requirement to provide any security or provision for costs whatsoever.

## SCHEDULE "A" TO APPROVAL AND VESTING ORDER

### LIST OF DEBTOR'S ASSETS

The Approval and Vesting Order extends to the universality of all the Debtor's moveable and immovable property, corporeal and incorporeal, present and future, of any nature whatsoever and wheresoever situated, the whole including without limitation:

#### I. Immovables

All the immovable properties of the Debtor along with all property permanently physically attached or joined thereto so as to ensure the utility thereof and which become immovable by the effect of law, including, without limitation, the following immovable properties:

- all claims (as such term is used in the Mining Act (Québec)) currently owned by the Debtor and described in Appendix 1 below (the "**Mineral Claims**"); and
- the universality of any and all existing and future mineral titles in any form whatsoever, including claims (whether staked or map-designated), mining exploration licences, mining leases, exploration licences, leases to mine, mining concessions or any other mining right, title or interest issued under the Mining Act (Québec), that may from time to time result from the Mineral Claims (the "**Other Rights**"); and
- the universality of any renewals or restakings of or substitutions for such Mineral Claims or Other Rights;

(all such present and future immovables being collectively hereinafter referred to as the "**Immovables**").

#### II. Rentals, Revenues and Leases of Immovables

all rentals, annuities and revenues emanating from the Immovables as well as any other right of the Debtor in any lease, present and future, which may affect the Immovables;

#### III. Rental Insurance

proceeds from any insurance covering losses of the rentals, annuities and revenues described in paragraph II. hereinabove;

#### IV. Charged Claims, Book Debts and Other Movable Property

i. Charged Claims, Receivables and Book Debts

all of the Debtor 's claims, debts, demands and choses in action, whatever their cause or nature, whether or not they are certain, liquid or exigible; whether or not evidenced by any title (and whether or not such title is negotiable), bill of exchange or draft, whether litigious or not, whether or not they have been previously or are to be invoiced and whether or not they constitute book debts.

ii. Rights of Action

the Debtor 's rights under contract with third parties as well as the Debtor 's rights of action and claims against any Person, including, without limitation, the Claim and in the Award;

iii. Accessories

all the securities, security agreements, guarantees, suretyships, notes and accessories to the claims and rights mentioned above and other rights relating thereto (including, without limitation, the rights of the Debtor in its capacity as seller under an instalment sale or a conditional sale, where the claims are the result of such sale);

iv. Movable Property

all movable property owned by the Debtor;

v. Tax credits and reimbursements

any and all tax credits and reimbursements, including income tax, R&D and input tax credits;

V. Securities

all securities (including shares, debentures, units, bonds, obligations, rights, options, warrants, debt securities, investment certificates, units in mutual funds) held by the Debtor or on its behalf, as well as all those which are delivered by the Debtor to the Attorney or to a third party on its behalf from time to time;

VI. Equipment and Road Vehicles

all the equipment, office furniture, tools, machinery, rolling stock (including road vehicles), spare parts and additions;

VII. Trade Marks and Other Intellectual Property Rights

all of the Debtor's rights in any trademark, copyright, industrial design, patent, invention, trade secret, know-how, plant breeders' right, topography of integrated circuits and in any other intellectual property right (registered or not) including, if any, improvements and modifications thereto as well as rights in any action pertaining to the protection, in Canada or abroad, of any such intellectual property rights;

#### VIII. Fruits and Revenues

all fruits and revenues emanating from the above Charged Property, including, without limitation, equipment, negotiable instruments, bills, commercial paper, securities, monies, compensation for expropriation given or paid following a sale, repurchase, distribution or any other operation concerning any property hereby charged in favour of the Attorney or which has been charged under any other deed;

#### IX. Records and Others

all records, data, vouchers, invoices and other documents related to the Charged Property including, without limitation, computer programs, disks, tapes and other means of electronic communications, as well as the rights of the Debtor to recover such property from third parties, receipts, client lists, directories and other similar property
