UPON THE APPLICATION FOR BANKRUPTCY ORDER (the “**Application**”) filed by National Bank of Canada (the “**Applicant**”), creditor of BOS Solutions Ltd. (“**BSL**”), filed the 14th day of June, 2021; **AND UPON HAVING READ** the Application and the Affidavit of Truth of Audrey Ng, sworn on May 28, 2021 (the “**Affidavit**”), filed in support hereof; **AND UPON HAVING READ** the Affidavit of Service of Katie Doran, sworn on July 22, 2021 (the “**Service Affidavit**”), filed; **AND UPON NOTING** the consent of Ernst & Young Inc., in its capacity as court-appointed trustee in bankruptcy of BSL (the “**Trustee**”) to the within Order; **AND UPON HEARING** the submissions of counsel for the Applicant, with no one appearing for any other person on the service list, although properly served as appears from the Affidavit of Service; **AND UPON** it appearing that all interested and affected parties have been served with notice of this Application; **AND UPON** it appearing to the Court that the following acts of bankruptcy have been committed by BSL:

- (a) the debts owing by BSL exceed \$1,000; and
- (b) within the 6 months preceding the date of filing of the Application for Bankruptcy Order, BSL ceased to meet its liabilities generally as they become due.

IT IS HEREBY ORDERED AS FOLLOWS:

1. The time for service of the Application is abridged, if necessary, the Application is properly returnable today, service of the Application on the service list (the "**Service List**") attached as Exhibit "A" to the Service Affidavit, in the manner described in the Service Affidavit, is good and sufficient, and no other persons other than those listed on the Service List, are entitled to service of the Application.
2. BSL, a corporation who carries on business in Alberta and is extra-provincially registered in the Province of Alberta, be and is hereby adjudged bankrupt and that a Bankruptcy Order is hereby made against BSL.
3. EY be and is hereby appointed as trustee of the estate of the bankrupt, BSL, without security.
4. The costs of and incidental to this Application and of this Order be paid to the Applicant, on a full indemnity, solicitor and his own client basis, out of the assets of the estate of the bankrupt, BSL, forthwith.
5. This Order must be served only upon those interested parties attending or represented at the within application and serve may be effected by facsimile, electronic mail, personal delivery or courier. Service is deemed to be effected the next business day following the transmission or delivery of such documents.
6. Service of this Order on any party not attending this Application is hereby dispensed with.
