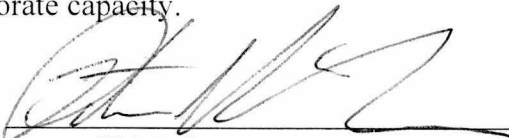
B. Unless otherwise indicated herein, capitalized terms not defined herein have the meaning attributed to them in the Seventh Report of the Receiver.
