In the Matter of the Receivership of Western Oilfield Equipment Rentals Ltd. ("Western Oilfield")

 Please be advised that on November 3, 2021, Ernst & Young Inc. was appointed as Receiver and Manager (the "Receiver") of the current and future assets, undertakings, and properties (the "Property") of Western Oilfield pursuant to an Order (the "Receivership Order") of the Honorable Justice A.D. Grosse of the Court of Queen's Bench of Alberta. A consolidated summary of the net book value of the Property of Western Oilfield is provided below:
