**AFFIDAVIT OF SHARON HAMILTON

I, **Sharon S. Hamilton**, of the City of Toronto, in the Province of Ontario, **MAKE OATH
AND SAY AS FOLLOWS:**

1. I am a Senior Vice President with Ernst & Young Inc. (“**EYI**”), the Court Appointed Monitor (the “**Monitor**”) for Laurentian University of Sudbury (the “**Applicant**”) and, as such, I have knowledge of the matters to which I hereinafter depose. Unless I indicate to the contrary, the facts herein are within my personal knowledge and are true. Where I have indicated that I have obtained facts from other sources, I believe those facts to be true. The Monitor does not, and does not intend to, waive privilege by any statement herein or in the Monitor’s Twelfth Report to the Court (the “**Twelfth Report**”).
2. This affidavit is filed in support of the Monitor’s motion for approval of the accounts of the Monitor, including the accounts of the Ernst & Young LLP accounting professionals (“**EY FAAS**”) (in connection with the Accounting Assistance, as defined in the Twelfth Report) and of Monitor’s counsel, Stikeman Elliott LLP (“**Stikeman**”) incurred during the period February 1, 2021 to December 31, 2021 (the “**Period**”).
3. Attached hereto as **Exhibit “A”** is a schedule summarizing, for each invoice issued by the Monitor during the Period, the fees of the Monitor, the fees of EY FAAS in respect of the Accounting Assistance, disbursements, fees of the Monitor’s counsel and HST billed for each invoice. As shown in the summary schedule, during the Period, the

Monitor billed \$4,917,795.07 in respect of Monitor Fees, \$947,900 in respect of the Accounting Assistance provided by EY FAAS, \$54,874.22 in disbursements and harmonized sales tax of \$1,130,417.73.

4. Attached hereto as **Exhibit "B"** are true copies of the invoices prepared by the Monitor during the Period for fees and disbursements incurred by the Monitor.
5. To the best of my knowledge, the rates charged by the Monitor and the EY FAAS team throughout the course of these proceedings are comparable to the rates charged by other professional firms in the Toronto market for the provision of similar services.
6. Further information with respect to the fees and disbursements charged is provided in the Twelfth Report.
7. I verily believe that the fees and disbursements charged by the Monitor, including those of the EY FAAS team are fair and reasonable in the circumstances of this proceeding.
8. This Affidavit is sworn in connection with a motion by the Monitor for the approval of the fees and disbursements of the Monitor and its legal counsel and for no improper purpose.

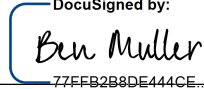
