Approval of Trustees Activities

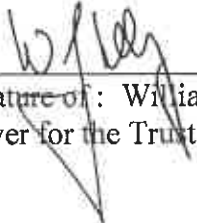
3. The activities of the Trustee, as set out in the followings reports, are hereby approved:
