(Corporate Access Number: 2021462961), and Sustainable Produce Urban Delivery Inc. (Incorporation Number: BC1014739) are herein referred to as (the “**Vested Debtors**”).

On October 18, 2022, the Supreme Court of British Columbia granted an order (the “**Approval and Vesting Order**”) approving a purchase and sale agreement for the sale of the assets and certain shares of the above noted companies (the “**Freshlocal Transaction**”).

Pursuant to the Approval and Vesting Order, the Monitor incorporated 139 and the liabilities of the Vested Debtors have vested absolutely and exclusively in 139. For clarity, if you previously had a claim against one of the Vested Debtors, you no longer have a claim against that entity. You now have a claim against 139, a bankrupt, without any assets.

On June 28, 2023 the Companies sought and obtained an order of the Supreme Court of British Columbia to consolidate the bankrupt estates of the Companies on a substantive and administrative basis. The effective date of bankruptcy for the consolidated estate of the Companies is June 26, 2023.
