Notice and Statement of the Receiver

(Subsections 245(1) and 246(1) of the Act)

The receiver gives notice and declares that:

- 1. On the 26th day of June 2023 (the "Receivership Date"), Ernst & Young Inc. was appointed Receiver and Manager (the "Receiver") of all the assets, undertakings and property of Seymour Health Centre Inc. ("Seymour"), including all proceeds arising therefrom, except and excluding from prosecuting, continuing, settling, or compromising the proceeding previously filed by Seymour and filed in the Vancouver Registry as File No. S234193 (the "Property").
- 2. The net book value of the Property, as indicated below, represents the values indicated on the unaudited financial statements provided by management on the Receivership Date (unless otherwise stated).

(b) Principal line of business:

Seymour developed and operates three health care clinics.

The Hornby Clinic provides integrated health care services, operating both a primary care clinic (a "PCC") and an urgent primary care clinic ("UPCC"), in addition to having provided other services such as diagnostic imaging, and laboratory services to the general public.

The West 7th Clinic operates as a PCC where general medical practitioners and other health care practitioners provide primary care services to the general public.

The Esplanade Clinic operates as a UPCC that provides same-day, urgent, nonemergency health care to the general public.

The services provided to the public and patients at each of the clinics continue unfettered by the receivership proceeding. The Receiver has secured a financial commitment from Vancouver Coastal Health to maintain the same level of quality care at the clinics as previously provided.

(c) Location(s) of business:

The Debtor has locations at the addresses stated above.

(f) The intended plan of action of the Receiver during the Receivership, to the extent that such a plan has been determined is as follows:

The Receiver will carry on the operation of the UPCC's under the transitional provisions of a service agreement with Vancouver Coastal Health ("VCH") until VCH assumes operational control; estimated to be August 2023. With respect to the PCCs, the Receiver will conduct a court approved sales process for the PCCs in the coming months. It is anticipated that VCH will submit a bid to acquire these clinics to preserve and ensure the level of care necessary to meet the needs of the patients and the citizens of British Columbia. The Receiver expects an outcome from the sales process in or around late summer or early fall 2023.
