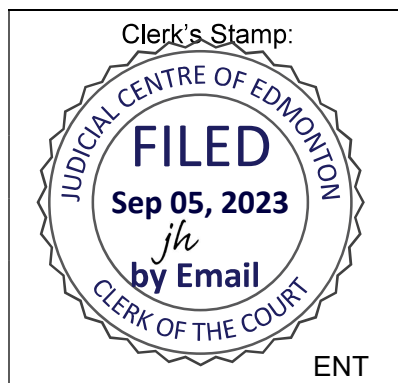

UPON THE APPLICATION of Ernst & Young Inc. (the "Receiver"), solely in its capacity as Court-Appointed Receiver of Careadon Corp. (the "Debtor"), for an Order, *inter alia*, sealing the Confidential Supplement to the Receiver's First Report to the Court (the "First Report") submitted by the Receiver and dated August 21, 2023 (the "Confidential Supplement"); **AND UPON** having read the Receivership Order granted July 7, 2023, and all application materials, filed; **AND UPON** hearing from counsel for the Receiver and all other interested parties present; **IT IS HEREBY ORDERED AND DECLARED THAT:**

1. The time for service of notice of this application is hereby abridged to that given, and service is deemed good and sufficient.

4. Service of this Order shall be deemed good and sufficient by:

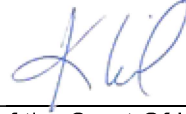
