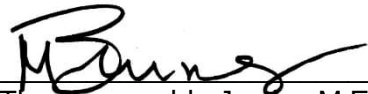
NAME OF JUSTICE WHO MADE THIS ORDER:

**UPON THE APPLICATION** of UMC Financial Services Inc. ("**UMC**"); **AND UPON** hearing from counsel for Servus; **AND UPON** reviewing the Affidavit of Daneka-Lee Puech, filed; **AND UPON** reviewing the Affidavit of Service of Samantha Hallett sworn November 14, 2023, filed and the Affidavit of Tomoe Aoki sworn November 16, 2023, unfiled; **AND UPON** being satisfied that Careadon Corp. has committed an act of bankruptcy within the meaning of subsection 42(1) of the *BIA* in the six (6) months preceding the filing of the within Application, and specifically that Careadon Corp. has failed to meet his obligations generally as they fall due;

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. The time for service of the notice of application and accompanying materials for this order (the "**Order**") is hereby abridged and deemed good and sufficient and this application is properly returnable today.
2. Careadon Corp. is hereby adjudged bankrupt by virtue of a bankruptcy order hereby made on this date.
3. Ernst & Young Inc. is hereby appointed as Trustee in Bankruptcy for Careadon Corp.
