To the Creditors of Weboook Information Technology Ltd.:

On June 19, 2025, Weboook Information Technology Ltd. (“**Weboook**”) filed a Notice of Intention to Make a Proposal (“**NOI**”) pursuant to the provisions of the *Bankruptcy and Insolvency Act* (“**BIA**”), and Ernst & Young Inc. was appointed as Proposal Trustee (the “**Trustee**”).

Pursuant to the BIA, the effect of filing an NOI is an automatic stay of proceedings, which prohibits all creditors from continuing or commencing any actions, execution or proceeding against Weboook for an initial stay period of 30 days (the “**Stay Period**”), although the Court may extend this period.

You will find enclosed herewith the following documents:

- a copy of the notice of intention;
- the certificate of filing of an NOI issued by the Official Receiver; and
- a preliminary list of creditors with claims of \$250 or more.

During the NOI proceeding, Weboook continues to operate in the ordinary course of business. The Trustee is responsible for monitoring Weboook’s business and affairs during the Stay Period and reporting any material adverse changes to the Office of the Superintendent of Bankruptcy and the Court.

Weboook intends to seek Court approval for, among other things, a sale and investment solicitation process (the “**SISP**”) as well as an interim financing agreement. The proposed SISP aims to solicit interest in an acquisition or refinancing of the business, or a sale of the assets and/or business of Weboook, through various means such as merger, reorganization, recapitalization, primary equity issuance, or other similar transactions. The proposed deadline to submit a binding offer is July 14, 2025.
