

**Notice and Statement of the Receiver**  
(Subsections 245(1) and 246(1) of the Act)

The receiver gives notice and declares that:

- On the 8th day of November 2025 (the “**Receivership Date**”), pursuant to Section 243(1) of the *Bankruptcy Insolvency Act* (the “**BIA**”) and Section 39 of the *Law and Equity Act* (the “**LEA**”), Ernst & Young Inc. was appointed Receiver and Manager (the “**Receiver**”) without security, of certain lands and other assets, undertakings and property of Evergreen Future Investments (2016) Inc. (“**Evergreen**”), AMCCO Carrier Ltd. (“**AMCCO**”), Never Delay Service Transport Inc. (“**Never Delay**”), Athabasca Farms Ltd.
