**UPON** the application of Stevan Perry ("**Mr. Perry**"), filed February 26, 2026, as amended (the "**Application**"), in the within *Companies' Creditors Arrangement Act*, 1985 c C-36 proceedings (the "**CCAA Proceedings**"); **AND UPON** having read the Application, the First Affidavit of Mr. Perry filed February 26, 2026, the Second Affidavit of Mr. Perry filed March 2, 2026, the Third Affidavit of Mr. Perry filed March 2, 2026, the Fourth Affidavit of Mr. Perry filed March 2, 2026, the Fifth Affidavit of Mr. Perry sworn March 5, 2026, and the amended Brief of Law of Mr. Perry filed February 26, 2026; **AND UPON** having read the Brief of Law of Sirona Pharma Inc., SuneRa Acreage Holdings Inc., Acreage Development Corp., and Sirona Farms Inc. (collectively, the "**CCAA Applicants**"), the Transcript of Questioning of Mr. Perry filed on

March 3, 2026, and the Responses to Undertakings of Mr. Perry dated March 4, 2025; **AND UPON** having read the Third Report of the Monitor, Ernst & Young Inc. (the “**Monitor**”), filed March 6, 2026; **AND UPON** noting the Affidavits and other evidence listed at paragraphs 36-47 of the Application filed February 26, 2026; **AND UPON** hearing submissions from Mr. Perry, counsel for the CCAA Applicants, counsel for the Monitor, and from any other parties present;

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. The Application is hereby dismissed in its entirety.
2. Mr. Perry is directed to pay costs in the amount of \$5,000.00 to the CCAA Applicants.
3. Mr. Perry is prohibited from taking any further or additional steps in the within CCAA Proceedings, including filing any further applications, until he has paid the full amount of \$5,000.00 in accordance with paragraph 2 herein.
4. Compliance with Rule 9.2(2) of the *Alberta Rules of Court*, Alta Reg 124/2010 and the requirement for all parties to approve this form of Order is hereby waived.
