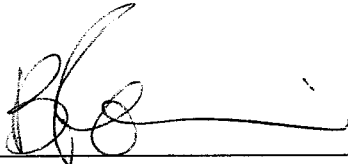

1. Service of this application is hereby waived and deemed to be good and sufficient.

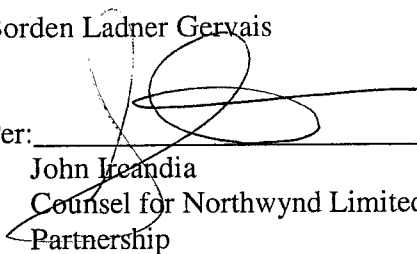

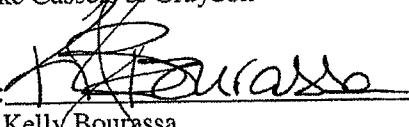

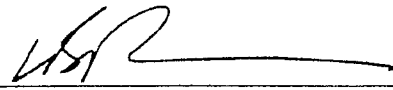
