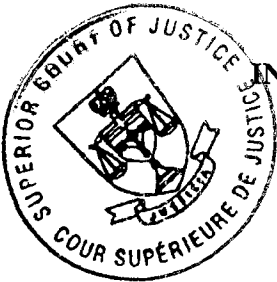

(Re Approval of Fees)

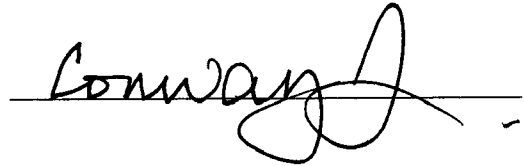
