(collectively the "**Applicants**") before the Honourable Madam Justice B.E.C. Romaine, in Chambers, at the Calgary Courts Centre, 601 - 5th Street S.W., in the City of Calgary, Province of Alberta on Thursday, the 29th day of October, 2009 at the hour of 1:15 o'clock in the afternoon or so soon thereafter as Counsel may be heard for:

1. An Order declaring service of notice of this application and the supporting materials to be good and sufficient, and abridging the time therefore, if necessary;

2. An Order extending the Stay Period (as such terms is defined in the Initial Order granted by the Honourable Madam Justice B.E.C. Romaine on July 29, 2009 (the "**Initial Order**")) in these proceedings to December 18, 2009.

3. Amending the style of cause in these proceedings to:

- (c) Concrete Associates VIII Corp. is an Applicant pursuant to the Receivership Order granted by the Honourable Madam Justice Romaine on July 29, 2009 and was inadvertently not included in the original style of cause in this matter.

AND FURTHER TAKE NOTICE that the Applicants will rely upon the Affidavit of Vincenzo De Palma sworn October 26, 2009, filed, and the second report of the Monitor, to be filed, the pleadings and other materials filed herein, the provisions of the *Companies' Creditors*

Arrangement Act (Canada) and the *Alberta Rules of Court*, and such further and other material as Counsel may advise and this Honourable Court may permit.

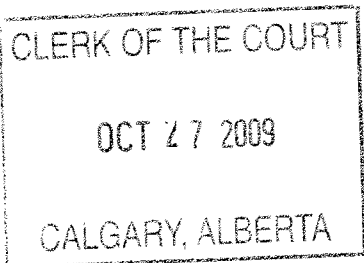
